PERINTAH RACUN (PINDAAN SENARAI RACUN) 2023

POISONS ACT 1952

POISONS (AMENDMENT OF POISONS LIST) ORDER 2023

IN exercise of the powers conferred by section 6 of the Poisons Act 1952 [Act 366], the Minister, after consultation with the Poisons Board, makes the following order:

Citation

1. This order may be cited as the **Poisons (Amendment of Poisons List) Order 2023**.

Amendment of First Schedule

2. The Poisons Act 1952 is amended in the First Schedule, in the Poisons List, in the list of “Alkaloids; the following: their salts, simple or complex; their quaternary compounds:”, by substituting for the item “Nicotine” and the particulars relating to it the following item and particulars:
