PERATURAN-PERATURAN INDUSTRI PERKHIDMATAN AIR
(KADAR PERKHIDMATAN BEKALAN AIR) (NEGERI PULAU PINANG) (PINDAAN) 2023

PADA menjalankan kuasa yang diberikan oleh perenggan 84(2)(a) dan 179(i) Akta Industri Perkhidmatan Air 2006 [*Akta 655*], Menteri, atas syor Suruhanjaya, membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Industri Perkhidmatan Air (Kadar Perkhidmatan Bekalan Air) (Negeri Pulau Pinang) (Pindaan) 2023**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 April 2023.

2. Peraturan-Peraturan Industri Perkhidmatan Air (Kadar Perkhidmatan Bekalan Air) (Negeri Pulau Pinang) 2010 [*P.U. (A) 334/2010*] dipinda dalam Jadual Pertama dengan menggantikan butir-butir yang berhubungan dengan “Domestik (meter pukal)” dengan butir-butir yang berikut:

Jumlah penggunaan	Kadar setiap meter padu (RM)	Kadar minimum (setiap bulan) (RM)
“kadar rata	1.66	16.60”.

WATER SERVICES INDUSTRY ACT 2006

WATER SERVICES INDUSTRY (RATES FOR WATER SUPPLY SERVICES)
(STATE OF PENANG) (AMENDMENT) REGULATIONS 2023

IN exercise of the powers conferred by paragraphs 84(2)(a) and 179(i) of the Water Services Industry Act 2006 [Act 655], the Minister, on the recommendation of the Commission, makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Water Services Industry (Rates for Water Supply Services) (State of Penang) (Amendment) Regulations 2023**.

(2) These Regulations come into operation on 1 April 2023.

Amendment of First Schedule

2. The Water Services Industry (Rates for Water Supply Services) (State of Penang) Regulations 2010 [P.U. (A) 334/2010] are amended in the First Schedule by substituting for the particulars relating to “Domestic (bulk meter)” the following particulars:

Amount of consumption	Rate per cubic metre (RM)	Minimum charge (per month) (RM)
“flat rate	1.66	16.60”.
