PERINTAH KOPERASI (PENGAMBILALIHAN KAWALAN KOPERASI PEKERJA-PEKERJA  
KERAJAAN SABAH BERHAD) (PELANTIKAN SEMULA) 2023

PADA menjalankan kuasa yang diberikan oleh perenggan 69(2)(a) dan subseksyen 69A(2) Akta Koperasi 1993 [*Akta 502*], Suruhanjaya membuat perintah yang berikut:

**Nama**

1. Perintah ini bolehlah dinamakan **Perintah Koperasi (Pengambilalihan Kawalan Koperasi Pekerja-Pekerja Kerajaan Sabah Berhad) (Pelantikan Semula) 2023**.

**Pelantikan semula bagi pengambilalihan kawalan**

2. Suruhanjaya melantik semula Kastian bin Dula untuk mengambil alih kawalan semua harta, urusan, aktiviti dan hal ehwal Koperasi Pekerja-Pekerja Kerajaan Sabah Berhad, dan menjalankan kesemua urusan, aktiviti dan hal ehwalnya bagi tempoh mulai 30 Oktober 2021 hingga 29 April 2022 atau sehingga suatu Lembaga baharu dipilih di bawah undang-undang kecil Koperasi Pekerja-Pekerja Kerajaan Sabah Berhad, mengikut mana-mana yang terdahulu.

**Kos, perbelanjaan dan saraan**

3. Apa-apa kos dan perbelanjaan yang dilakukan oleh Suruhanjaya, dan saraan bagi orang yang dilantik semula di bawah perenggan 2, berhubung dengan pengambilalihan kawalan di bawah perenggan 2 hendaklah kena dibayar daripada dana dan harta Koperasi Pekerja-Pekerja Kerajaan Sabah Berhad sebagai suatu caj pertama.

CO-OPERATIVE SOCIETIES ACT 1993

CO-OPERATIVE SOCIETIES (ASSUMPTION OF CONTROL OF KOPERASI  
PEKERJA-PEKERJA KERAJAAN SABAH BERHAD) (REAPPOINTMENT) ORDER 2023

IN exercise of the powers conferred by paragraph 69(2)(a) and subsection 69A(2) of the Co-operative Societies Act 1993 [Act 502], the Commission makes the following order:

**Citation**

1. This order may be cited as the **Co-operative Societies (Assumption of Control of Koperasi Pekerja-Pekerja Kerajaan Sabah Berhad) (Reappointment) Order 2023**.

**Reappointment of assumption of control**

2. The Commission reappoints Kastian bin Dula to assume control of the whole of the property, business, activities and affairs of the Koperasi Pekerja-Pekerja Kerajaan Sabah Berhad, and carry on the whole of its business, activities and affairs for the period from 30 October 2021 to 29 April 2022 or until a new Board is elected under the by-laws of the Koperasi Pekerja-Pekerja Kerajaan Sabah Berhad, whichever is earlier.

**Costs, expenses and remuneration**

3. Any costs and expenses incurred by the Commission, and the remuneration of the person reappointed under paragraph 2, in relation to the assumption of control under paragraph 2 shall be payable out of the funds and properties of the Koperasi Pekerja-Pekerja Kerajaan Sabah Berhad as a first charge.
