AKTA PASARAN MODAL DAN PERKHIDMATAN 2007

PERINTAH PASARAN MODAL DAN PERKHIDMATAN
(PENETAPAN SEKURITI) (WARAN KOMODITI) 2023

PADA menjalankan kuasa yang diberikan oleh subseksyen 5(1) Akta Pasaran Modal dan Perkhidmatan 2007 [*Akta 671*], Menteri, atas syor Suruhanjaya, membuat perintah yang berikut:

Nama

1. Perintah ini bolehlah dinamakan **Perintah Pasaran Modal dan Perkhidmatan (Penetapan Sekuriti) (Waran Komoditi) 2023**.

Tafsiran

2. Dalam Perintah ini, “waran komoditi” ertinya suatu derivatif yang didagangkan pada suatu bursa saham yang seseorang pemegang itu mempunyai suatu hak untuk menerima suatu jumlah tunai, bergantung kepada naik-turunnya nilai atau harga suatu sandaran—

(a) komoditi; atau

(b) derivatif komoditi yang didagangkan di bursa derivatif atau Bursa Ditetapkan.

Waran komoditi ditetapkan sebagai sekuriti

3. Suatu waran komoditi ditetapkan sebagai sekuriti bagi maksud undang-undang sekuriti.

CAPITAL MARKETS AND SERVICES ACT 2007

CAPITAL MARKETS AND SERVICES (PRESCRIPTION OF SECURITIES)
(COMMODITY WARRANTS) ORDER 2023

IN exercise of the powers conferred by subsection 5(1) of the Capital Markets and Services Act 2007 [Act 671], the Minister, on the recommendation of the Commission, makes the following order:

Citation

1. This order may be cited as the **Capital Markets and Services (Prescription of Securities) (Commodity Warrants) Order 2023**.

Interpretation

2. In this Order, “commodity warrant” means a derivative that is traded on a stock exchange which the holder has a right to receive a cash amount, depending on the fluctuations in the value or price of an underlying—

(a) commodity; or

(b) commodity derivatives traded on a derivatives exchange or Specified Exchange.

Commodity warrants prescribed to be securities

3. A commodity warrant is prescribed to be securities for the purposes of securities laws.
