Pindaan Jadual Pertama

2. Jadual Pertama kepada Akta Dadah Berbahaya 1952 dipinda dalam Bahagian III—

(a) dengan memasukkan selepas butiran “Bezitramide” butiran yang berikut:

“Brorphine”;

(b) dengan memasukkan selepas butiran “Etryptamine” butiran yang berikut:

“Eutylone”; dan

(c) dengan memasukkan selepas butiran “4-methylthioamphetamine (4-MTA)” butiran yang berikut:

“Metonitazene”.

DANGEROUS DRUGS ACT 1952

DANGEROUS DRUGS (AMENDMENT OF FIRST SCHEDULE) (NO. 2) ORDER 2023

IN exercise of the powers conferred by section 45A of the Dangerous Drugs Act 1952 [*Act 234*], the Minister makes the following order:

Citation

1. This order may be cited as the **Dangerous Drugs (Amendment of First Schedule) (No. 2) Order 2023**.

Amendment of First Schedule

2. The First Schedule to the Dangerous Drugs Act 1952 is amended in Part III—

(a) by inserting after the item “Bezitramide” the following item:

“Brorphine”;

(b) by inserting after the item “Etryptamine” the following item:

“Eutylone”; and

(c) by inserting after the item “4-methylthioamphetamine (4-MTA)” the following item:

“Metonitazene”.
