PERINTAH KAWALAN BEKALAN  
(PENGECCUALIAN DARIPADA PELESENAN) 2023

PADA menjalankan kuasa yang diberikan oleh seksyen 5A Akta Kawalan Bekalan 1961 [*Akta 122*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Kawalan Bekalan (Pengecualian daripada Pelesenan) 2023**.

(2) Perintah ini mula berkuat kuasa pada 1 Mac 2023.

**Pengecualian**

2. Menteri mengecualikan mana-mana pengilang dan penjual runcit yang berniaga, sama ada dengan cara jual borong atau jual runcit, apa-apa barang berjadual yang dinyatakan dalam butiran 12 Bahagian 1 Jadual kepada Peraturan-Peraturan Kawalan Bekalan 1974 [*P.U. (A) 103/1974*] daripada kehendak pelesenan di bawah peraturan 3 Peraturan-Peraturan itu.

CONTROL OF SUPPLIES ACT 1961

CONTROL OF SUPPLIES  
(EXEMPTION FROM LICENSING) ORDER 2023

IN exercise of the powers conferred by section 5A of the Control of Supplies Act 1961 [*Act 122*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Control of Supplies (Exemption from Licensing) Order 2023**.

(2) This Order comes into operation on 1 March 2023.

**Exemption**

2. The Minister exempts any manufacturer and retailer who deals in, either by wholesale or retail, any scheduled articles specified in item 12 Part 1 of the Schedule to the Control of Supplies Regulation 1974 [*P.U. (A) 103/1974*] from the requirement of licensing under regulation 3 of the Regulations.
