(JALAN PERSEKUTUAN) (NO. 17) (PEMBATALAN) 2023

ROAD TRANSPORT ACT 1987

ROAD TRANSPORT (PROHIBITION OF USE OF ROAD)  
(FEDERAL ROADS) (NO. 17) (REVOCATION) ORDER 2023

IN exercise of the powers conferred by section 70 of the Road Transport Act 1987 [Act 333], the Minister of Works, after taking into consideration the matters referred to in subsection 70(2) of the Act, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Road Transport (Prohibition of Use of Road) (Federal Roads) (No. 17) (Revocation) Order 2023**.

(2) This Order comes into operation on 28 February 2023.

**Revocation**

2. The Road Transport (Prohibition of Use of Road) (Federal Roads) (No. 17) Order 2022 [*P.U. (A) 358/2022*] is revoked.
