AKTA PERKHIDMATAN KEWANGAN 2013

PERINTAH PERKHIDMATAN KEWANGAN (PENGECUALIAN) 2023

PADA menjalankan kuasa yang diberikan oleh seksyen 263 Akta Perkhidmatan Kewangan 2013 [*Akta 758*], Menteri, atas syor Bank, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Perkhidmatan Kewangan (Pengecualian) 2023**.

(2) Perintah ini berkuat kuasa mulai 1 Mac 2023 hingga 30 Jun 2027.

2. Menteri mengecualikan Bank Pembangunan Malaysia Berhad daripada pemakaian perenggan 8(1)(a) Akta bagi maksud menjalankan perniagaan insurans jaminan kewangan yang dipindahkan daripada Danajamin Nasional Berhad kepada Bank Pembangunan Malaysia Berhad sebagaimana yang dinyatakan dalam Jadual bagi tempoh mulai 1 Mac 2023 hingga 30 Jun 2027.

FINANCIAL SERVICES ACT 2013

FINANCIAL SERVICES (EXEMPTION) ORDER 2023

IN exercise of the powers conferred by section 263 of the Financial Services Act 2013 [*Act 758*], the Minister, on the recommendation of the Bank, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Financial Services (Exemption) Order 2023**.

(2) This Order has effect from 1 March 2023 to 30 June 2027.

Exemption

2. The Minister exempts Bank Pembangunan Malaysia Berhad from the application of paragraph 8(1)(a) of the Act for the purpose of carrying on the financial guarantee insurance business transferred from Danajamin Nasional Berhad to Bank Pembangunan Malaysia Berhad as specified in the Schedule for the period from 1 March 2023 to 30 June 2027.
