ENERGY COMMISSION ACT 2001

ENERGY COMMISSION (SUSPENSION OF OPERATION OF THE ACT FOR SABAH)
ORDER 2023

IN exercise of the powers conferred by subsection 1(4) of the Energy Commission Act 2001 [*Act 610*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Energy Commission (Suspension of Operation of the Act for Sabah) Order 2023**.

(2) This Order comes into operation on 10 January 2023.

Suspension of operation of the Act

2. The Minister suspends the operation of sections 2 and 14 of the Act in relation to gas supply for Sabah.
