Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Had Laju Tempatan (Jalan Persekutuan) (Malaysia Barat) (Pindaan) (No. 3) 2022**.

(2) Perintah ini mula berkuat kuasa pada 31 Disember 2022.

ROAD TRANSPORT ACT 1987

LOCAL SPEED LIMIT (FEDERAL ROADS) (WEST MALAYSIA)
(AMENDMENT) (NO. 3) ORDER 2022

IN exercise of the powers conferred by subsection 69(2) of the Road Transport Act [Act 333], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Local Speed Limit (Federal Roads) (West Malaysia) (Amendment) (No. 3) Order 2022**.

(2) This Order comes into operation on 31 December 2022.

Amendment of First Schedule

2. The Local Speed Limit (Federal Roads) (West Malaysia) Order 1992 [P.U. (A) 462/1991] is amended in the First Schedule under the heading "STATE OF TERENGGANU" by inserting after item 44 the following item:

(1) Road name and location	(2) Speed limit (km/h)

From Kampung Seberang Baruh N 5.307319, 60".
E 103.113888 to intersection Kampung Tok Kaya
N 5.306963, E 103.123624 (a distance of 1.092 km)
