## AKTA JALAN PERSEKUTUAN 1959

## PERINTAH JALAN PERSEKUTUAN (SKIM FELDA) (PINDAAN) 2022

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Sabah, membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Skim Felda) (Pindaan) 2022**.

(2) Perintah ini mula berkuat kuasa pada 31 Disember 2022.

**Pindaan Jadual Pertama**

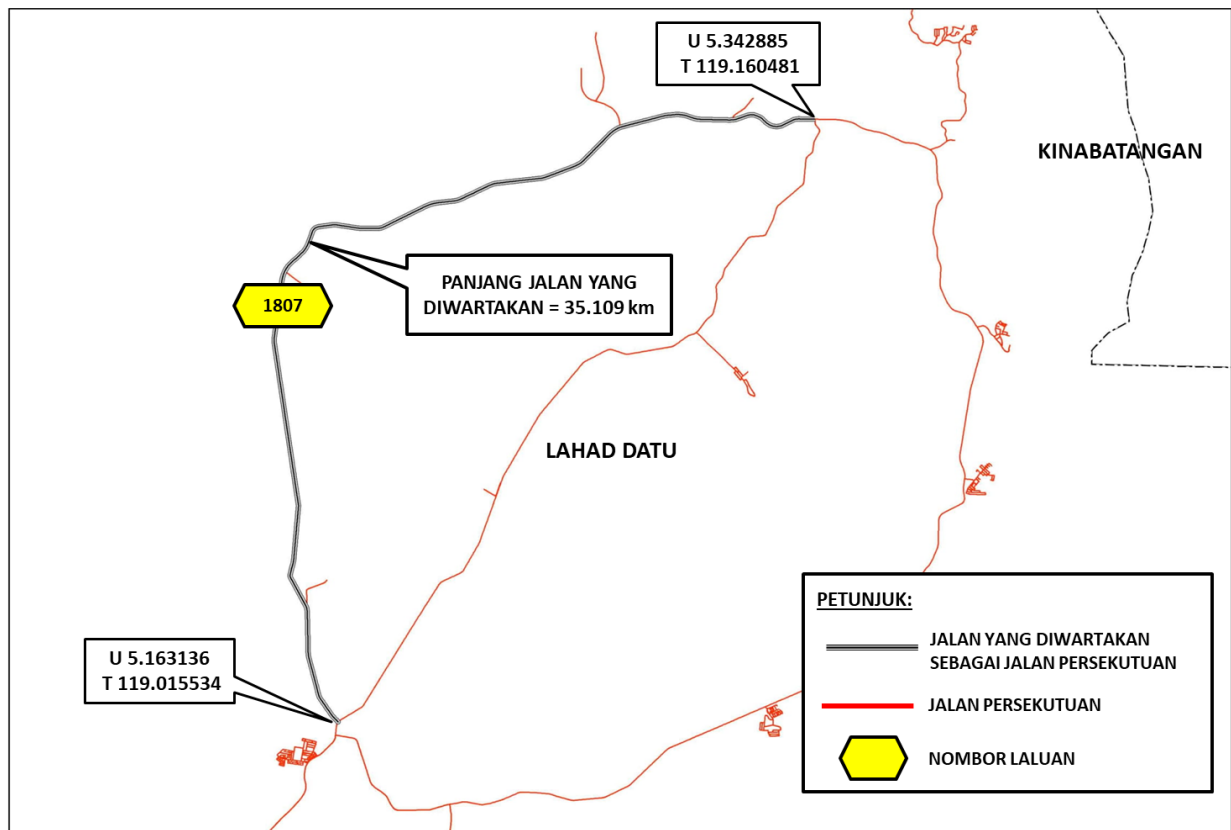
2. Perintah Jalan Persekutuan (Skim Felda) 1991 [P.U. (A) 449/1991], yang disebut "Perintah ibu" dalam Perintah ini, dipinda dalam Jadual Pertama di bawah kepala Negeri Sabah dengan memasukkan selepas butiran "Sahabat H" dan butir-butir yang berhubungan dengannya butiran dan butir-butir yang berikut:

## FEDERAL ROADS ACT 1959

## FEDERAL ROADS (FELDA SCHEME) (AMENDMENT) ORDER 2022

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Sabah, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (Felda Scheme) (Amendment) Order 2022**.

(2) This Order comes into operation on 31 December 2022.

**Amendment of First Schedule**

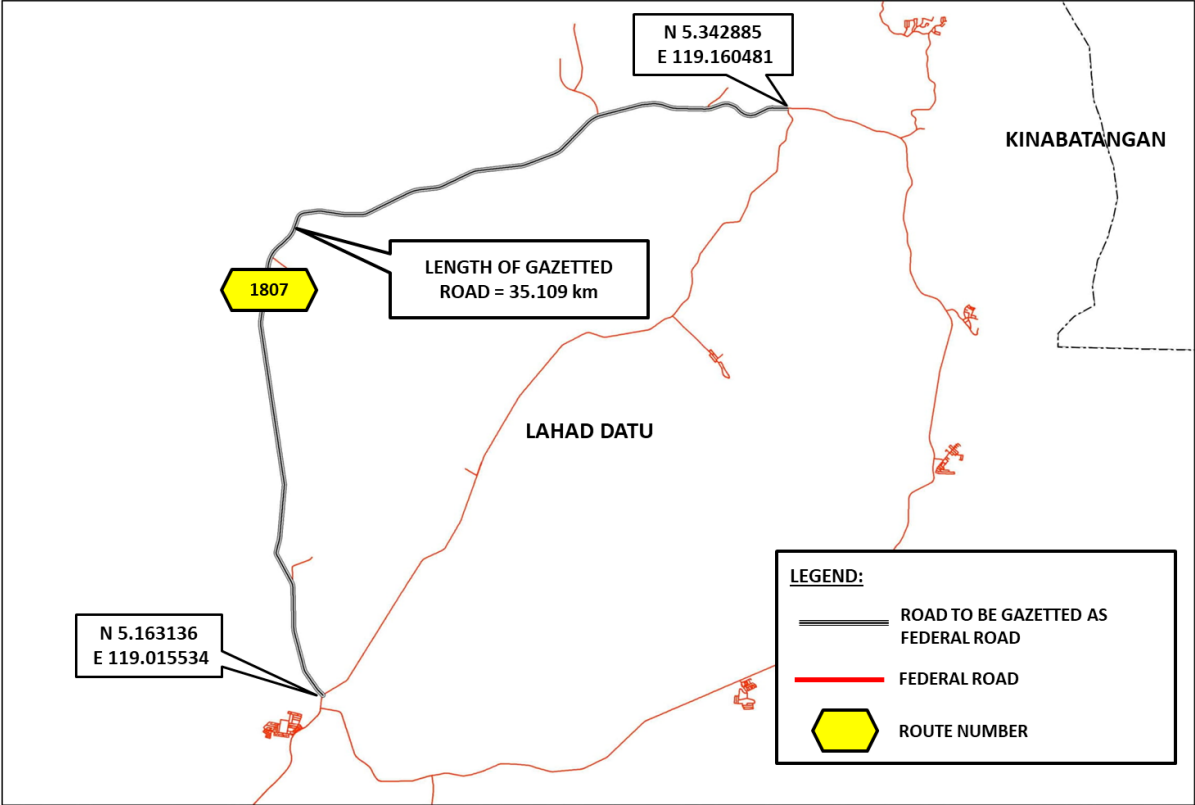
2. The Federal Roads (Felda Scheme) Order 1991 [*P.U. (A) 449/1991*], which is referred to as the “principal Order” in this Order, is amended in the First Schedule under the heading of State of Sabah by inserting after item “Sahabat H” and the particulars relating to it the following item and particulars:

<i>Name of FELDA Scheme</i>	<i>Route Number for Approach Roads</i>	<i>Approach Roads (km)</i>	<i>Village Roads (km)</i>
“Sahabat (West Ring)	1807	35.109	—”.
