ROAD TRANSPORT ACT 1987

ROAD TRANSPORT (PROHIBITION OF USE OF ROAD)  
(FEDERAL ROADS) (NO. 15) (REVOCATION) (NO. 2) ORDER 2022

IN exercise of the powers conferred by section 70 of the Road Transport Act 1987 [Act 333], the Minister of Works, after taking into consideration the matters referred to in subsection 70(2) of the Act, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Road Transport (Prohibition of Use of Road) (Federal Roads) (No. 15) (Revocation) (No. 2) Order 2022**.

(2) This Order comes into operation on 15 December 2022.

**Revocation**

2. The Road Transport (Prohibition of Use of Road) (Federal Road) (No. 15) Order 2022 [*P.U. (A) 286/2022*] is revoked.
