Nama

EMPLOYMENT INSURANCE SYSTEM ACT 2017

EMPLOYMENT INSURANCE SYSTEM (SUPPLY) REGULATIONS 2022

IN exercise of the powers conferred by subsection 48(1) of the Employment Insurance System Act 2017 [Act 800], the Minister makes the following regulations:

Citation

1. These regulations may be cited as the **Employment Insurance System (Supply) Regulations 2022**.

Issue for expenditure for the year 2022

2. The issue of a sum not exceeding three hundred and thirty-three million eight hundred and twenty-six thousand ringgit (RM333,826,000) from the Employment Insurance Fund for the expenditure on administration of the Employment Insurance System for the year 2022 is hereby authorized for the purpose specified in the Schedule.
