SELF-EMPLOYMENT SOCIAL SECURITY ACT 2017

SELF-EMPLOYMENT SOCIAL SECURITY (SUPPLY) REGULATIONS 2022

IN exercise of the powers conferred by subsection 47(1) of the Self-Employment Social Security Act 2017 [Act 789], the Minister makes the following regulations:

Citation

1. These regulations may be cited as the **Self-Employment Social Security (Supply) Regulations 2022**.

Issue for expenditure for the year 2022

2. The issue of a sum not exceeding nineteen million one hundred and twenty-five thousand ringgit (RM19,125,000) from the Self-Employment Social Security Fund for the expenditure on the administration of the Self-Employment Social Security Scheme for the year 2022 is hereby authorized for the purpose specified in the Schedule.
