## AKTA KESELAMATAN SOSIAL PEKERJA 1969

## PERATURAN-PERATURAN KESELAMATAN SOSIAL PEKERJA (PERBEKALAN) 2022

PADA menjalankan kuasa yang diberikan oleh seksyen 72 Akta Keselamatan Sosial Pekerja 1969 [Akta 4], Menteri membuat peraturan-peraturan yang berikut:

**Nama**

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Keselamatan Sosial Pekerja (Perbekalan) 2022**.

2. Pengeluaran sejumlah wang yang tidak melebihi satu bilion sembilan puluh dua juta lapan ratus lapan puluh tiga ribu ringgit (RM1,092,883,000) daripada Kumpulan Wang Keselamatan Sosial bagi perbelanjaan untuk pentadbiran Rancangan Keselamatan Sosial bagi tahun 2022 adalah dengan ini dibenarkan bagi maksud yang dinyatakan dalam Jadual.

## EMPLOYEES' SOCIAL SECURITY ACT 1969

## EMPLOYEES' SOCIAL SECURITY (SUPPLY) REGULATIONS 2022

IN exercise of the powers conferred by section 72 of the Employees' Social Security Act 1969 [Act 4], the Minister makes the following regulations:

**Citation**

1. These regulations may be cited as the **Employees' Social Security (Supply) Regulations 2022**.

**Issue for expenditure for the year 2022**

2. The issue of a sum not exceeding one billion ninety-two million eight hundred and eighty-three thousand ringgit (RM1,092,883,000) from the Social Security Fund for the expenditure on administration of the Scheme of Social Security for the year 2022 is hereby authorized for the purpose specified in the Schedule.
