PERINTAH PERNIAGAAN PERKHIDMATAN WANG
(EJEN PERNIAGAAN PERKHIDMATAN WANG) (PENGECCUALIAN) 2022

2. Menteri mengeccualikan seseorang yang menyediakan perkhidmatan perbankan ejen di bawah Akta Perkhidmatan Kewangan 2013 [*Akta 758*], Akta Perkhidmatan Kewangan Islam 2013 [*Akta 759*] atau Akta Institusi Kewangan Pembangunan 2002 [*Akta 618*] daripada pemakaian perenggan 45(1)(a) Akta.

MONEY SERVICES BUSINESS ACT 2011

MONEY SERVICES BUSINESS (MONEY SERVICES BUSINESS AGENT)
(EXEMPTION) ORDER 2022

IN exercise of the powers conferred by section 91 of the Money Services Business Act 2011 [*Act 731*], the Minister makes the following order:

Citation

1. This order may be cited as the **Money Services Business (Money Services Business Agent) (Exemption) Order 2022**.

Exemption from paragraph 45(1)(a)

2. The Minister exempts a person who provides agent banking services under the Financial Services Act 2013 [*Act 758*], Islamic Financial Services Act 2013 [*Act 759*] or Development Financial Institutions Act 2002 [*Act 618*] from the application of paragraph 45(1)(a) of the Act.
