AKTA JAMINAN PINJAMAN (PERTUBUHAN PERBADANAN) 1965

PERINTAH JAMINAN PINJAMAN (PERTUBUHAN PERBADANAN)
(PEREMITAN CUKAI DAN DUTI SETEM) (NO. 2) 2022 (PINDAAN) 2022

PADA menjalankan kuasa yang diberikan oleh subseksyen 10(1) Akta Jaminan Pinjaman (Pertubuhan Perbadanan) 1965 [*Akta 96*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jaminan Pinjaman (Pertubuhan Perbadanan) (Peremitan Cukai dan Duti Setem) (No. 2) 2022 (Pindaan) 2022**.

(2) Perintah ini mula berkuat kuasa pada 12 Oktober 2022.

Pindaan am

2. Perintah Jaminan Pinjaman (Pertubuhan Perbadanan) (Peremitan Cukai dan Duti Setem) (No. 2) 2022 [*P.U. (A) 93/2022*], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dengan menggantikan perkataan “Nota Jangka Sederhana Islam” di mana-mana jua terdapat dengan perkataan “Kertas Komersial Islam dan Nota Jangka Sederhana Islam”.

Pindaan perenggan 2

3. Perintah ibu dipinda—

(a) dalam subsubperenggan 2(1)(a), dengan memasukkan selepas perkataan “TRX City Sdn. Bhd.” perkataan “(dahulunya dikenali sebagai 1MDB Real Estate Sendirian Berhad)”; dan

(b) dalam subsubperenggan 2(1)(b), dengan menggantikan perkataan “satu bilion ringgit (RM1,000,000,000.00)” dengan perkataan “satu bilion sembilan ratus juta ringgit (RM1,900,000,000.00)”.

Pindaan perenggan 3

4. Perenggan 3 Perintah ibu dipinda—

(a) dalam subsubperenggan (a)—

(i) dengan memotong perkataan “(dahulunya dikenali sebagai 1MDB Real Estate Sendirian Berhad)”; dan

(ii) dengan menggantikan perkataan “Perintah Jaminan Pinjaman (Penetapan Pertubuhan Perbadanan) (TRX City Sdn. Bhd.) 2012” dengan perkataan “Perintah Jaminan Pinjaman (Penetapan Pertubuhan Perbadanan) (TRX City Sdn. Bhd. (dahulunya dikenali sebagai 1MDB Real Estate Sendirian Berhad)) 2012”; dan

(b) dalam subsubperenggan (d), dengan menggantikan perkataan “dan/atau” dengan perkataan “atau”.

LOANS GUARANTEE (BODIES CORPORATE) ACT 1965

LOANS GUARANTEE (BODIES CORPORATE) (REMISSION OF TAX AND STAMP DUTY)
(NO. 2) 2022 (AMENDMENT) ORDER 2022

IN exercise of the powers conferred by subsection 10(1) of the Loans Guarantee (Bodies Corporate) Act 1965 [*Act 96*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Loans Guarantee (Bodies Corporate) (Remission of Tax and Stamp Duty) (No. 2) 2022 (Amendment) Order 2022**.

(2) This Order comes into operation on 12 October 2022.

General amendment

2. The Loans Guarantee (Bodies Corporate) (Remission of Tax and Stamp Duty) (No. 2) Order 2022 [*P.U. (A) 93/2022*], which is referred to as the “principal Order” in this Order, is amended by substituting for the words “the Islamic Medium Term Notes” wherever appearing the words “the Islamic Commercial Papers and the Islamic Medium Term Notes”.

Amendment of paragraph 2

3. The principal Order is amended—

(a) in subparagraph 2(1)(a), by inserting after the words “TRX City Sdn. Bhd.” the words “(formerly known as 1MDB Real Estate Sendirian Berhad)”; and

(b) in subparagraph 2(1)(b), by substituting for the words “one billion ringgit (RM1,000,000,000.00)” the words “one billion nine hundred million ringgit (RM1,900,000,000.00)”.

Amendment of paragraph 3

4. Paragraph 3 of the principal Order is amended—

(a) in subparagraph (a)—

(i) by deleting the words “(formerly known as 1MDB Real Estate Sendirian Berhad)”; and

(ii) by substituting for the words “the Loans Guarantee (Declaration of Bodies Corporate) (TRX City Sdn. Bhd.) Order 2012” the words “the Loans Guarantee (Declaration of Bodies Corporate) (TRX City Sdn. Bhd. (formerly known as 1MDB Real Estate Sendirian Berhad)) Order 2012”; and

(b) in subparagraph (d), by substituting for the words “and/or” the word “or”.
