PERINTAH DUTI KASTAM (PENGECUALIAN) 2017 (PINDAAN) (NO. 5) 2022

PADA menjalankan kuasa yang diberikan oleh subseksyen 14(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Duti Kastam (Pengecualian) 2017 (Pindaan) (No. 5) 2022**.

(2) Perintah ini mula berkuat kuasa pada 23 September 2022.

2. Perintah Duti Kastam (Pengecualian) 2017 [*P.U. (A) 445/2017*] dipinda dalam Bahagian I Jadual, berhubung dengan butiran 67, dalam ruang (2), dalam perenggan (vi), dengan menggantikan perkataan “Repsol Oil & Gas Malaysia Limited.” dengan perkataan “Hibiscus Oil & Gas Malaysia Limited”.

CUSTOMS ACT 1967

CUSTOMS DUTIES (EXEMPTION) 2017 (AMENDMENT) (NO. 5) ORDER 2022

IN exercise of the powers conferred by subsection 14(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs Duties (Exemption) 2017 (Amendment) (No. 5) Order 2022**.

(2) This Order comes into operation on 23 September 2022.

Amendment of Schedule

2. The Customs Duties (Exemption) Order 2017 [*P.U. (A) 445/2017*] is amended in Part I of the Schedule, in relation to item 67, in column (2), in paragraph (vi), by substituting for the words “Repsol Oil & Gas Malaysia Limited.” the words “Hibiscus Oil & Gas Malaysia Limited”.
