(MAJLIS PERUNDINGAN KOPERASI KEBANGSAAN) (PINDAAN) (NO. 2) 2022

PADA menjalankan kuasa yang diberikan oleh perenggan 86(2)(m) Akta Koperasi 1993 [*Akta 502*], Suruhanjaya, dengan kelulusan Menteri, membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Koperasi (Majlis Perundingan Koperasi Kebangsaan) (Pindaan) (No. 2) 2022**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 15 September 2022.

2. Peraturan-Peraturan Koperasi (Majlis Perundingan Koperasi Kebangsaan) 2010 [*P.U. (A) 130/2010*] dipinda dalam teks bahasa Inggeris, dalam peraturan 6, dengan menggantikan subperaturan (1) dengan subperaturan yang berikut:

“(1) Subject to the terms and conditions as stated in the letter of appointment, a member of the Council appointed under paragraphs 5(c), (i) and (j) shall hold the post for a period of not exceeding two years and is eligible to be reappointed.”.

CO-OPERATIVE SOCIETIES ACT 1993

CO-OPERATIVE SOCIETIES (THE NATIONAL CO-OPERATIVE
CONSULTATIVE COUNCIL) (AMENDMENT) (NO. 2) REGULATIONS 2022

IN exercise of the powers conferred by paragraph 86(2)(m) of the Co-operative Societies Act 1993 [Act 502], the Commission, with the approval of the Minister, makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Co-operative Societies (The National Co-operative Consultative Council) (Amendment) (No. 2) Regulations 2022**.

(2) These Regulations come into operation on 15 September 2022.

Amendment of regulation 6

2. The Co-operative Societies (The National Co-operative Consultative Council) 2010 [P.U. (A) 130/2010] is amended in the english language text, in regulation 6, by substituting for subregulation (1) the following subregulation:

“(1) Subject to the terms and conditions as stated in the letter of appointment, a member of the Council appointed under paragraphs 5(c), (i) and (j) shall hold the post for a period of not exceeding two years and is eligible to be reappointed.”.
