PRICE CONTROL AND ANTI-PROFITEERING (PRICE MARKING OF  
PRICE-CONTROLLED GOODS) (NO. 7) (AMENDMENT) ORDER 2022

IN exercise of the powers conferred by section 10 of the Price Control and Anti-Profiteering Act 2011 [Act 723], the Minister makes the following order:

**Citation**

1. This order may be cited as the **Price Control and Anti-Profiteering (Price Marking of Price-Controlled Goods) (No. 7) (Amendment) Order 2022**.

**Amendment of paragraph 1**

2. The Price Control and Anti-Profiteering (Price Marking of Price-Controlled Goods) (No. 7) Order 2022 [P.U. (A) 224/2022] is amended in subparagraph 1(2) by deleting the words “for the period” and “to 31 August 2022”.
