PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 11) 2022

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Pahang, membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 11) 2022**.

(2) Perintah ini mula berkuat kuasa pada 1 September 2022.

**Pindaan Jadual Pertama**

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [P.U. (A) 401/1989] dipinda dalam Jadual Pertama di bawah kepala "**Negeri Pahang Darul Makmur**"—

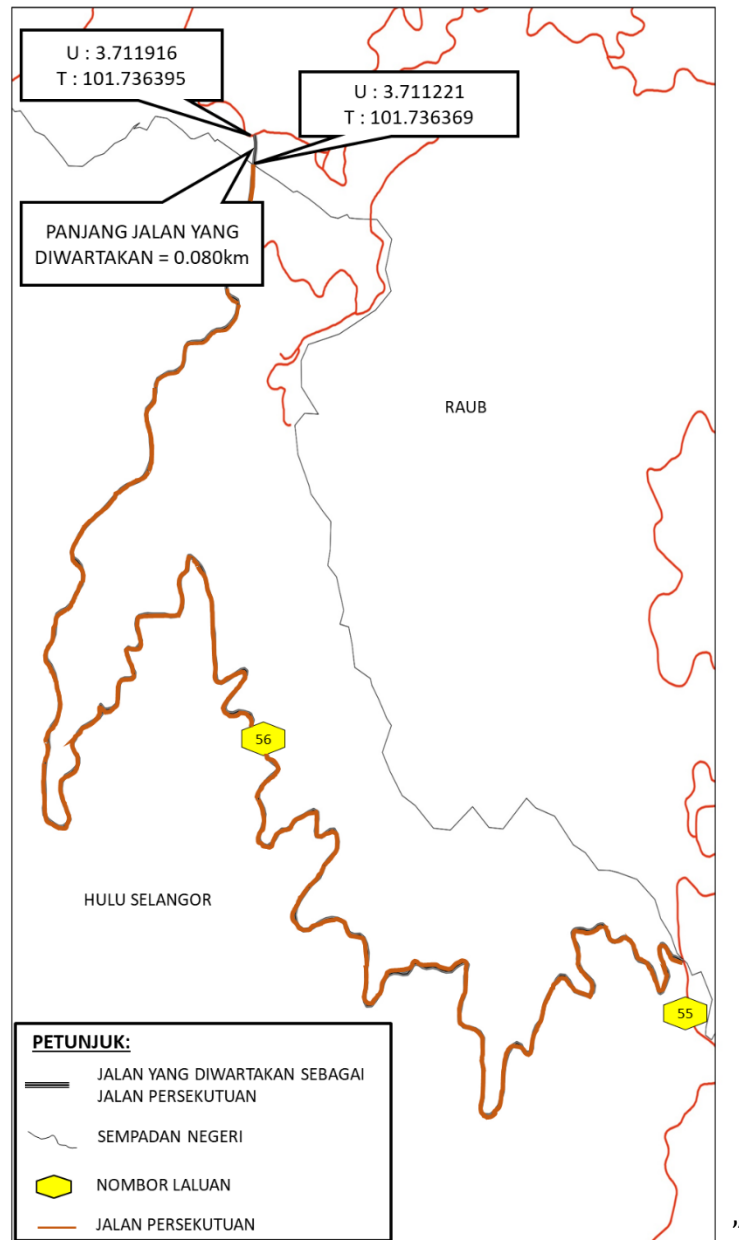
(a) dengan menggantikan butiran 12 dengan butiran yang berikut:

"12. *(Laluan 56): Jalan Gap – Bukit Fraser*

Bermula dari sempadan negeri Selangor dan Pahang di koordinat U 3.711221, T 101.736369 dan berakhir di koordinat U 3.711916, T 101.736395 di dalam sempadan hak lalu-lalang sebagaimana yang ditunjukkan dalam PETA 32: JALAN GAP - BUKIT FRASER (jarak sepanjang 0.080km)."; dan

(b) dengan memasukkan selepas PETA 31: PERSIARAN PELABUHAN KUANTAN peta yang berikut:

“PETA 32: JALAN GAP - BUKIT FRASER

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 11) ORDER 2022

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Pahang, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 11) Order 2022**.

(2) This Order comes into operation on 1 September 2022.

**Amendment of First Schedule**

2. The Federal Roads (West Malaysia) Order 1989 [P.U. (A) 401/1989] is amended in the First Schedule under the heading of “**Negeri Pahang Darul Makmur**” —

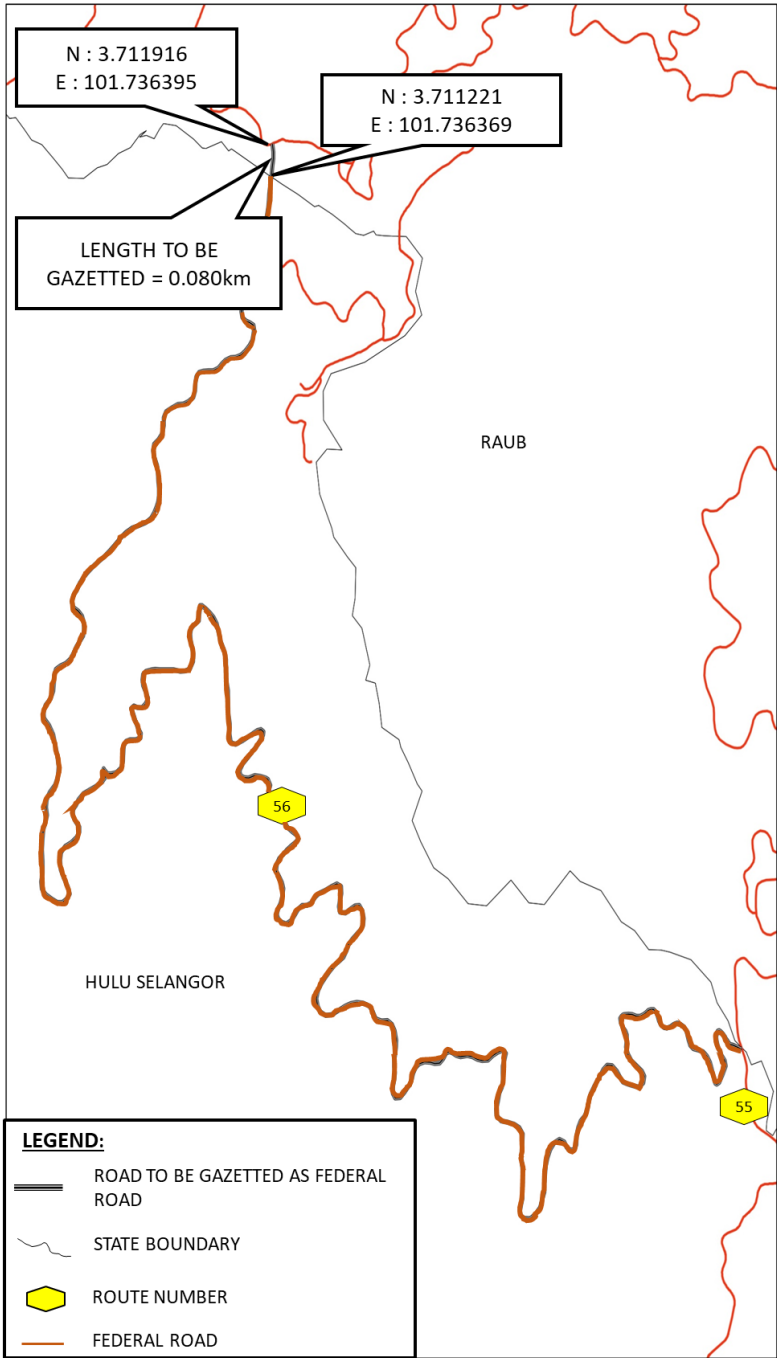
(a) by substituting for item 12 the following item:

“12. *(Route 56): Gap - Fraser Hill Road*

Starting from Selangor and Pahang state boundary at coordinates N 3.711221, E 101.736369 and ending at coordinates N 3.711916, E 101.736395 within the boundaries of right of way as shown on MAP 32: GAP - FRASER HILL ROAD (a distance of 0.080km).”; and

(b) by inserting after MAP 31: KUANTAN PORT PROMENADE the following map:
