**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Menteri-Menteri Kerajaan Persekutuan (No. 3) (Pindaan) (No. 3) 2022**.

(2) Perintah ini mula berkuat kuasa pada 15 Ogos 2022.

2. Perintah Menteri-Menteri Kerajaan Persekutuan (No. 3) 2021 [*P.U. (A) 383/2021*] dipinda dalam Jadual—

(a) berkenaan dengan Jabatan Perdana Menteri, dengan memasukkan selepas butiran “Teraju Bumiputera Corporation” dalam ruang “*Jabatan/Perkara*” butiran “Institut Kajian Strategik dan Antarabangsa (ISIS) Malaysia”; dan

(b) berkenaan dengan Kementerian Luar Negeri, dengan memotong butiran “Institut Kajian Strategik dan Antarabangsa (ISIS) Malaysia” dalam ruang “*Jabatan/Perkara*”.

MINISTERIAL FUNCTIONS ACT 1969

MINISTERS OF THE FEDERAL GOVERNMENT (NO.3)  
(AMENDMENT) (NO. 3) ORDER 2022

IN exercise of the powers conferred by section 2 of the Ministerial Functions Act 1969 [Act 2], the Yang di-Pertuan Agong makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Ministers of the Federal Government (No. 3) (Amendment) (No. 3) Order 2022**.

(2) This Order comes into operation on 15 August 2022.

**Amendment of Schedule**

2. The Ministers of the Federal Government (No. 3) Order 2021 [*P.U. (A) 383/2021*] is amended in the Schedule—

(a) in respect of the Prime Minister's Department, by inserting after the item "Teraju Bumiputera Corporation" in the "*Department/Subject*" column the item "Institute of Strategic and International Studies (ISIS) Malaysia"; and

(b) in respect of Ministry of Foreign Affairs, by deleting the item "Institute of Strategic and International Studies (ISIS) Malaysia" in the "*Department/Subject*" column.
