CONTROL OF SUPPLIES ACT 1961

CONTROL OF SUPPLIES (PROHIBITION ON EXPORT)  
(AMENDMENT) (REVOCATION) REGULATIONS 2022

IN exercise of the powers conferred by paragraph 6(2)(b) of the Control of Supplies Act 1961 [*Act 122*], the Minister makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Control of Supplies (Prohibition on Export) (Amendment) (Revocation) Regulations 2022**.

(2) These Regulations come into operation on 1 August 2022.

**Revocation**

2. The Control of Supplies (Prohibition on Export) (Amendment) Regulations 2022 [*P.U. (A) 228/2022*] are revoked.
