PERATURAN-PERATURAN INDUSTRI PERKHIDMATAN AIR
(KADAR PERKHIDMATAN BEKALAN AIR) (NEGERI PULAU PINANG) (PINDAAN) 2022

PADA menjalankan kuasa yang diberikan oleh perenggan 84(2)(a) dan 179(i) Akta Industri Perkhidmatan Air 2006 [*Akta 655*], Menteri, atas syor Suruhanjaya, membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Industri Perkhidmatan Air (Kadar Perkhidmatan Bekalan Air) (Negeri Pulau Pinang) (Pindaan) 2022**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Ogos 2022.

WATER SERVICES INDUSTRY ACT 2006

WATER SERVICES INDUSTRY (RATES FOR WATER SUPPLY SERVICES)
(STATE OF PENANG) (AMENDMENT) REGULATIONS 2022

IN exercise of the powers conferred by paragraphs 84(2)(a) and 179(i) of the Water Services Industry Act 2006 [Act 655], the Minister, on the recommendation of the Commission, makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Water Services Industry (Rates for Water Supply Services) (State of Penang) (Amendment) Regulations 2022**.

(2) These Regulations come into operation on 1 August 2022.

Substitution of First Schedule

2. The Water Services Industry (Rates for Water Supply Services) (State of Penang) Regulations 2010 [*P.U. (A) 334/2010*], which are referred to as the “principal Regulations” in these Regulations, are amended by substituting for the First Schedule the following Schedule:

<i>Type of use</i>	<i>Description</i>
1. Domestic (individual meter)	Supply of water through individual meter or parcel meter to residential premises or units
2. Domestic (bulk meter)	Supply of water through bulk meter to high rise residential building, gated community, estate quarters and government quarters
3. Non-domestic	Commercial, industrial, trade, business, government premises, school, institute of higher learning, hospital, water processing industry (including water kiosk), plantation and farming
4. House of worship and welfare institution	House of worship which its construction was approved by the government under any written laws or its operation approved by the relevant religious bodies recognized by the government to give approvals for house of worship Welfare institution registered with the Department of Social Welfare or given tax exemptions by the Inland Revenue Board of Malaysia or recognized by the government as a welfare institution

<i>Type of use</i>	<i>Description</i>
5. Shipping	Supply of water for the use aboard ships anchored at port”.
