2. Jadual Kelapan kepada Akta Kumpulan Wang Simpanan Pekerja 1991 dipinda dalam jadual, dalam ruang (3), dengan menggantikan perkataan “9%” dengan perkataan “11%”.

EMPLOYEES PROVIDENT FUND ACT 1991

EMPLOYEES PROVIDENT FUND  
(AMENDMENT OF EIGHTH SCHEDULE) ORDER 2022

IN exercise of the powers conferred by section 74 of the Employees Provident Fund Act 1991 [Act 452], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Employees Provident Fund (Amendment of Eighth Schedule) Order 2022**.

(2) This Order comes into operation on 1 July 2022.

**Amendment of Eight Schedule**

2. The Eighth Schedule to the Employees Provident Fund Act 1991 is amended in the table, in column (3), by substituting for the words “9%” the words “11%”.
