AKTA JALAN PERSEKUTUAN 1959

PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 8) 2022

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [*Akta 376*], Menteri, setelah berunding dengan Kerajaan Negeri Sembilan, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 8) 2022**.

(2) Perintah ini mula berkuat kuasa pada 20 Jun 2022.

Pindaan Jadual Ketiga

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [*P.U. (A) 401/1989*] dipinda dalam Jadual Ketiga di bawah kepala “Negeri Sembilan Darul Khusus”—

(a) dengan memotong butiran 7; dan

(b) dengan memotong “PETA 2: JALAN-JALAN PERSEKUTUAN NEGERI SEMBILAN”.

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 8) ORDER 2022

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Negeri Sembilan, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 8) Order 2022**.

(2) This Order comes into operation on 20 June 2022.

Amendment of Third Schedule

2. The Federal Roads (West Malaysia) Order 1989 [P.U. (A) 401/1989] is amended in the Third Schedule under the heading of “Negeri Sembilan Darul Khusus”—

(a) by deleting item 7; and

(b) by deleting “MAP 2: FEDERAL ROADS OF NEGERI SEMBILAN”.
