AKTA JAMINAN PINJAMAN (PERTUBUHAN PERBADANAN) 1965

PERINTAH JAMINAN PINJAMAN (PERTUBUHAN PERBADANAN)  
(PEREMITAN CUKAI DAN DUTI SETEM) (NO. 6) 2020 (PINDAAN) 2022

PADA menjalankan kuasa yang diberikan oleh subseksyen 10(1) Akta Jaminan Pinjaman (Pertubuhan Perbadanan) 1965 [*Akta 96*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Jaminan Pinjaman (Pertubuhan Perbadanan) (Peremitan Cukai dan Duti Setem) (No. 6) 2020 (Pindaan) 2022**.

(2) Perintah ini mula berkuat kuasa pada 4 Jun 2022.

**Pindaan perenggan 2**

2. Perintah Jaminan Pinjaman (Pertubuhan Perbadanan) (Peremitan Cukai dan Duti Setem) (No. 6) 2020 [*P.U. (A) 360/2020*] yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam perenggan 2—

(a) dengan menomborkan semula perenggan itu sebagai subperenggan 2(1);

(b) dalam subperenggan (1) sebagaimana yang dinomborkan semula, dengan memotong perkataan “dan” di hujung subsubperenggan (b);

(c) dengan memasukkan selepas subsubperenggan (b) subsubperenggan yang berikut:

“(ba) Kemudahan Pusingan Kredit Islamik Bersindiket yang diperolehi atau akan diperolehi oleh Lembaga Kemajuan Tanah Persekutuan yang disebut “Kemudahan RC-i” dalam Perintah ini, dengan amaun agregat prinsipal tidak melebihi enam bilion ringgit (RM6,000,000,000.00); dan”;

- (d) dalam subsubperenggan (c), dengan memasukkan selepas perkataan “Program GG Sukuk Murabahah” perkataan “dan Kemudahan RC-i”; dan
- (e) dengan memasukkan selepas subperenggan (1) subperenggan yang berikut:

“(2) Bagi maksud subperenggan (1), agregat digabungkan nilai nominal belum berbayar Nota Jangka Sederhana Islam yang diterbitkan menurut Program GG Sukuk Murabahah dan amaun prinsipal belum berbayar yang diperoleh di bawah Kemudahan RC-i tidak boleh melebihi sembilan bilion sembilan ratus juta ringgit (RM9,900,000,000.00).”

### **Pindaan perenggan 3**

3. Perenggan 3 Perintah ibu dipinda—

- (a) dengan menggantikan perkataan “Program GG Sukuk Murabahah dan” dengan perkataan “Program GG Sukuk Murabahah, Kemudahan RC-i atau”;
- (b) dengan memotong perkataan “atau” di hujung subsubperenggan (b);
- (c) dengan memasukkan selepas subsubperenggan (b) subsubperenggan yang berikut:

“(ba) mana-mana pembiaya Kemudahan RC-i; atau”; dan

- (d) dalam subsubperenggan (c), dengan memasukkan selepas perkataan “Program GG Sukuk Murabahah” perkataan “, Kemudahan RC-i”.

### **Pindaan perenggan 4**

4. Perenggan 4 Perintah ibu dipinda dengan menggantikan perkataan “Program GG Sukuk Murabahah dan” dengan perkataan “Program GG Sukuk Murabahah, Kemudahan RC-i atau”.

LOANS GUARANTEE (BODIES CORPORATE) ACT 1965

LOANS GUARANTEE (BODIES CORPORATE) (REMISSION OF TAX AND STAMP DUTY)  
(NO. 6) 2020 (AMENDMENT) ORDER 2022

IN exercise of the powers conferred by subsection 10(1) of the Loans Guarantee (Bodies Corporate) Act 1965 [*Act 96*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Loans Guarantee (Bodies Corporate) (Remission of Tax and Stamp Duty) (No. 6) 2020 (Amendment) Order 2022**.

(2) This Order comes into operation on 4 June 2022.

**Amendment of paragraph 2**

2. The Loans Guarantee (Bodies Corporate) (Remission of Tax and Stamp Duty) (No. 6) Order 2020 [*P.U. (A) 360/2020*] which is referred to as “the principal Order” in this Order, is amended in paragraph 2—

(a) by renumbering the paragraph as subparagraph 2(1);

(b) in subparagraph (1) as renumbered, by deleting the word “and” at the end of subparagraph (b);

(c) by inserting after subparagraph (b) the following subparagraph:

“(ba) the Syndicated Revolving Credit-i Facility obtained or to be obtained by the Federal Land Development Authority which in this Order is referred to as the “RC-i Facility”, with the aggregate principal amount not exceeding six billion ringgit (RM6,000,000,000.00); and”;

(d) in subparagraph (c), by inserting after the words “GG Sukuk Murabahah Programme” the words “and the RC-i Facility”; and

(e) by inserting after subparagraph (1) the following subparagraph:

“(2) For the purpose of subparagraph (1), the combined aggregate of the outstanding nominal value of the Islamic Medium Term Notes issued pursuant to the GG Sukuk Murabahah Programme and the outstanding principal amount obtained under the RC-i Facility shall not exceed nine billion nine hundred million ringgit (RM9,900,000,000.00).”

### **Amendment of paragraph 3**

3. Paragraph 3 of the principal Order is amended—

(a) by substituting for the words “GG Sukuk Murabahah Programme and” the words “GG Sukuk Murabahah Programme, the RC-i Facility or”;

(b) by deleting the word “or” at the end of subparagraph (b);

(c) by inserting after subparagraph (b) the following subparagraph:

“(ba) any financier of the RC-i Facility; or”; and

(d) in subparagraph (c), by inserting after the words “GG Sukuk Murabahah Programme” the words “, the RC-i Facility”.

### **Amendment of paragraph 4**

4. Paragraph 4 of the principal Order is amended by substituting for the words “GG Sukuk Murabahah Programme and” the words “GG Sukuk Murabahah Programme, the RC-i Facility or the”.
