PERINTAH KASTAM (DUTI ANTI-LAMBAKAN) (NO. 2) 2020 (PINDAAN) 2022

PADA menjalankan kuasa yang diberikan oleh seksyen 25 Akta Duti Timbal Balas dan Anti-Lambakan 1993 [*Akta 504*] dan subseksyen 11(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Duti Anti-Lambakan) (No. 2) 2020 (Pindaan) 2022**.

(2) Perintah ini mula berkuat kuasa pada 1 Jun 2022.

2. Perintah Kastam (Duti Anti-Lambakan) (No. 2) 2020 [*P.U. (A) 94/2020*] dipinda dalam subperenggan 4(1), dengan menggantikan perkataan “Perintah Duti Kastam 2017 [*P.U. (A) 5/2017*]” dengan perkataan “Perintah Duti Kastam 2022 [*P.U. (A) 114/2022*]”.

COUNTERVAILING AND ANTI-DUMPING DUTIES ACT 1993 AND CUSTOMS ACT 1967

CUSTOMS (ANTI-DUMPING DUTIES) (NO. 2) 2020 (AMENDMENT) ORDER 2022

IN exercise of the powers conferred by section 25 of the Countervailing and Anti-Dumping Duties Act 1993 [*Act 504*] and subsection 11(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Anti-Dumping Duties) (No. 2) 2020 (Amendment) Order 2022**.

(2) This Order comes into operation on 1 June 2022.

Amendment of paragraph 4

2. The Customs (Anti-Dumping Duties) (No. 2) Order 2020 [*P.U. (A) 94/2020*], is amended in subparagraph 4(1), by substituting for the words “Customs Duties Order 2017 [*P.U. (A) 5/2017*]” the words “Customs Duties Order 2022 [*P.U. (A) 114/2022*]”.
