CUSTOMS ACT 1967

CUSTOMS (PROHIBITION OF REMOVAL) (AMENDMENT) ORDER 2022

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Prohibition of Removal) (Amendment) Order 2022**.

(2) This Order comes into operation on 1 June 2022.
