PERINTAH DUTI KASTAM (PENGECCUALIAN) 2017 (PINDAAN) (NO. 3) 2022

PADA menjalankan kuasa yang diberikan oleh subseksyen 14(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Duti Kastam (Pengeccualian) 2017 (Pindaan) (No. 3) 2022**.

(2) Perintah ini mula berkuat kuasa pada 1 Jun 2022.

2. Perintah Duti Kastam (Pengeccualian) 2017 [*P.U. (A) 445/2017*] dipinda dalam Bahagian 1 Jadual dengan memasukkan selepas butiran 115 dan butir-butir yang berhubungan dengannya butiran dan butir-butir yang berikut:

CUSTOMS ACT 1967

CUSTOMS DUTIES (EXEMPTION) 2017 (AMENDMENT) (NO. 3) ORDER 2022

IN exercise of the powers conferred by subsection 14(1) of the Customs Act 1967[Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs Duties (Exemption) 2017 (Amendment) (No. 3) Order 2022**.

(2) This Order comes into operation on 1 June 2022.

Amendment of Schedule

2. The Customs Duties (Exemption) Order 2017 [P.U. (A) 445/2017] is amended in Part I of the Schedule by inserting after item 115 and the particulars relating to it the following item and particulars:

"116.
