AKTA KUMPULAN WANG SIMPANAN PEKERJA 1991

KAEDAH-KAEDAH KUMPULAN WANG SIMPANAN PEKERJA (PINDAAN) (NO. 2) 2022

PADA menjalankan kuasa yang diberikan oleh seksyen 73 Akta Kumpulan Wang Simpanan Pekerja 1991 [*Akta 452*], Lembaga membuat kaedah-kaedah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Kaedah-kaedah ini bolehlah dinamakan **Kaedah-Kaedah Kumpulan Wang Simpanan Pekerja (Pindaan) (No. 2) 2022**.

(2) Kaedah-Kaedah ini mula berkuat kuasa pada 1 Julai 2022.

Pindaan kaedah 41

2. Kaedah-Kaedah Kumpulan Wang Simpanan Pekerja 1991 [*P.U. (A) 493/1991*], yang disebut “Kaedah-Kaedah ibu” dalam Kaedah-Kaedah ini, dipinda dalam kaedah 41 dengan memotong subkaedah (10F), (10N), (10O), (10P), (10Q), (10R), (10S), (10T), (10ZB), (10ZC), (10ZD), (10ZE), (10ZF), (10ZG), (10ZH), (10ZI), (10ZJ), (10ZK), (10ZL), (10ZM) dan (10ZN).

Kecualian

3. (1) Apa-apa notis pengeluaran yang dibuat di bawah perenggan 54(6)(*k*), (*l*), (*m*) atau (*n*) Akta pada atau sebelum 31 Mac 2021, 30 Jun 2021, 30 September 2021 atau 30 April 2022, masing-masing, yang belum selesai sebelum tarikh permulaan kuat kuasa Kaedah-Kaedah ini hendaklah, pada tarikh permulaan kuat kuasa Kaedah-Kaedah ini, diuruskan mengikut peruntukan Kaedah-Kaedah ibu seolah-olah Kaedah-Kaedah ibu tidak dipinda oleh Kaedah-Kaedah ini.

(2) Apa-apa kebenaran, arahan, keputusan atau tindakan pentadbiran lain yang dibuat, diberikan atau dilakukan berhubungan dengan subkaedah (10F), (10N), (10O), (10P), (10Q), (10R), (10S), (10T), (10ZB), (10ZC), (10ZD), (10ZE), (10ZF), (10ZG), (10ZH), (10ZI), (10ZJ), (10ZK), (10ZL), (10ZM) atau (10ZN) sebelum tarikh permulaan

kuat kuasa Kaedah-Kaedah ini hendaklah, pada tarikh permulaan kuat kuasa Kaedah-Kaedah ini, terus berkuat kuasa dan berkesan sepenuhnya berhubung dengan ahli Kumpulan Wang yang baginya kebenaran, arahan, keputusan atau tindakan pentadbiran lain itu terpakai sehingga dipinda, dimansuhkan, dihapuskan, dibatalkan atau digantikan.

(3) Apa-apa penyiasatan atau prosiding undang-undang yang dimulakan berhubung dengan subkaedah (10F), (10N), (10O), (10P), (10Q), (10R), (10S), (10T), (10ZB), (10ZC), (10ZD), (10ZE), (10ZF), (10ZG), (10ZH), (10ZI), (10ZJ), (10ZK), (10ZL), (10ZM) atau (10ZN) yang belum selesai sebelum tarikh permulaan kuat kuasa Kaedah-Kaedah ini hendaklah, pada tarikh permulaan kuat kuasa Kaedah-Kaedah ini, diteruskan mengikut peruntukan Kaedah-Kaedah ibu seolah-olah Kaedah-Kaedah ibu tidak dipinda oleh Kaedah-Kaedah ini.

EMPLOYEES PROVIDENT FUND ACT 1991

EMPLOYEES PROVIDENT FUND (AMENDMENT) (NO. 2) RULES 2022

IN exercise of the powers conferred by section 73 of the Employees Provident Fund Act 1991 [Act 452], the Board makes the following rules:

Citation and commencement

1. (1) These rules may be cited as the **Employees Provident Fund (Amendment) (No. 2) Rules 2022**.

(2) These Rules come into operation on 1 July 2022.

Amendment of rule 41

2. The Employees Provident Fund Rules 1991 [*P.U. (A) 493/1991*], which are referred to as “the principal Rules” in these Rules, are amended in rule 41 by deleting subrules (10F), (10N), (10O), (10P), (10Q), (10R), (10S), (10T), (10ZB), (10ZC), (10ZD), (10ZE), (10ZF), (10ZG), (10ZH), (10ZI), (10ZJ), (10ZK), (10ZL), (10ZM) and (10ZN).

Savings

3. (1) Any notice of withdrawal made under paragraph 54(6)(k), (l), (m) or (n) of the Act on or before 31 March 2021, 30 June 2021, 30 September 2021 or 30 April 2022, respectively, which is pending before the date of coming into operation of these Rules shall, on the date of coming into operation of these Rules, be dealt with in accordance with the provisions of the principal Rules as if the principal Rules had not been amended by these Rules.

(2) Any authorization, direction, decision or other executive acts made, given or done in relation to subrule (10F), (10N), (10O), (10P), (10Q), (10R), (10S), (10T), (10ZB), (10ZC), (10ZD), (10ZE), (10ZF), (10ZG), (10ZH), (10ZI), (10ZJ), (10ZK), (10ZL), (10ZM) or (10ZN) before the date of coming into operation of these Rules shall, on the date of coming into operation of these Rules, continue in full force and effect in relation to

the member of the Fund to whom the authorization, direction, decision or other executive acts applied until amended, repealed, rescinded, revoked or replaced.

(3) Any investigation or legal proceedings instituted in relation to subrule (10F), (10N), (10O), (10P), (10Q), (10R), (10S), (10T), (10ZB), (10ZC), (10ZD), (10ZE), (10ZF), (10ZG), (10ZH), (10ZI), (10ZJ), (10ZK), (10ZL), (10ZM) or (10ZN) which is pending before the date of coming into operation of these Rules shall, on the date of coming into operation of these Rules, be continued in accordance with the provisions of the principal Rules as if the principal Rules had not been amended by these Rules.
