PERATURAN-PERATURAN FRANCAIS
(KELAYAKAN BROKER FRANCAIS) (PINDAAN) 2022

PADA menjalankan kuasa yang diberikan oleh subseksyen 14(2) Akta Francois 1998 [*Akta 590*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Francois (Kelayakan Broker Francois) (Pindaan) 2022**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 28 April 2022.

Pindaan tajuk

2. Peraturan-Peraturan Francois (Kelayakan Broker Francois) 1999 [*P.U. (A) 423/1999*], yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda dalam tajuk dengan memasukkan selepas perkataan “Broker Francois” perkataan “atau Konsultan Francois”.

Peraturan baharu 1A

3. Peraturan-Peraturan ibu dipinda dengan memasukkan selepas peraturan 1 peraturan yang berikut:

“Tafsiran

1A. Dalam Peraturan-peraturan ini—

“kursus francais” ertinya kursus yang dianjurkan oleh Akademi Perbadanan Nasional Bhd atau apa-apa kursus francais lain yang diiktiraf oleh Pendaftar Francois;

“ijazah sarjana muda” ertinya apa-apa ijazah dalam bidang yang diiktiraf oleh Agensi Kelayakan Malaysia;

“diploma” ertinya apa-apa diploma dalam bidang yang diiktiraf oleh Agensi Kelayakan Malaysia.”.

Pindaan peraturan 2

4. Peraturan 2 dalam Peraturan-Peraturan ibu dipinda—

(a) dalam nota bahu, dengan memasukkan selepas perkataan “**broker francais**” perkataan “**atau konsultan francais**”;

(b) dalam subperaturan (1)—

(i) dengan memasukkan selepas perkataan “broker francais” perkataan “atau konsultan francais”;

(ii) di hujung perenggan (a), dengan memotong perkataan “dan”;

(iii) dalam subperenggan (b)(iii)—

(A) dengan menggantikan perkataan “selama tidak kurang daripada 10 tahun” dengan perkataan “selama tidak kurang 20 tahun, dengan 10 tahun pengalaman di peringkat eksekutif”; dan

(B) dengan menggantikan noktah di hujung subperenggan (b)(iii) dengan perkataan “; dan”; dan

(iv) dengan memasukkan selepas perenggan (b), perenggan yang berikut:

“(c) telah menghadiri kursus francais di peringkat nasional atau antarabangsa sebagaimana yang diarahkan oleh Pendaftar.”.

(c) dalam subperaturan (2)—

- (i) dengan memasukkan selepas perkataan “broker francais” perkataan “atau konsultan francais”; dan
- (ii) dengan menggantikan perenggan (b) dengan perenggan yang berikut:

“(b) terdiri daripada sekurang-kurangnya seorang ahli Lembaga Pengarah yang merupakan broker francais atau konsultan francais yang berdaftar di bawah Akta.”.

FRANCHISE ACT 1998

FRANCHISE (QUALIFICATIONS OF A FRANCHISE BROKER) (AMENDMENT)
REGULATIONS 2022

IN exercise of the powers conferred by subsection 14(2) of the Franchise Act 1998 [*Act 590*], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Franchise (Qualifications of a Franchise Broker) (Amendment) Regulations 2022**.

(2) These Regulations come into operation on 28 April 2022.

Amendment of title

2. The Franchise (Qualifications of A Franchise Broker) Regulations 1999 [*P.U. (A) 423/1999*], which are referred to as “principal Regulations” in these Regulations, are amended in the title by inserting after the words “Franchise Broker” the words “or Franchise Consultant”.

New regulation 1A

3. The principal Regulations is amended by inserting after regulation 1 the following regulation:

“Interpretation

1A. In these Regulations—

“franchise course” means a course organized by Akademi Perbadanan Nasional Bhd or any other franchise course recognized by the Registrar of Franchises;

“bachelor degree” means any bachelor degree certificate recognized by Malaysia Qualification Agency;

“diploma” means any diploma certificate recognized by Malaysia Qualification Agency.”.

Amendment of regulation 2

4. Regulation 2 of the principal Regulations is amended—

(a) in the shoulder note, by inserting after the words “**franchise broker**” the words “**or franchise consultant**”;

(b) in subregulation (1)—

(i) by inserting after the words “franchise broker” the words “or franchise consultant”;

(ii) at the end of paragraph (a), by deleting the word “and”;

(iii) in subparagraph (b)(iii)—

(A) by substituting for the words “for not less than 10 years” with the words “for not less than 20 years, with 10 years of experience in the executive level”; and

(B) by substituting for the full stop at the end of subparagraph (b)(iii) with the words “; and”; and

(iv) by inserting after paragraph (b), the following paragraph as follows:

“(c) have attended franchise course at the national or international level as directed by the Registrar.”.

(c) in subregulation (2)—

(i) by inserting after the words “franchise broker” the words “or franchise consultant”; and

(ii) by substituting for paragraph (b) the following paragraph:

“(b) consist of at least a member of a Board of Director who is a franchise broker or a franchise consultant registered under the Act.”.
