PERINTAH KAWALAN BEKALAN (BARANG-BARANG KAWALAN) (NO. 2) 2022

PADA menjalankan kuasa yang diberikan oleh seksyen 5 Akta Kawalan Bekalan 1961 [*Akta 122*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Kawalan Bekalan (Barang-Barang Kawalan) (No. 2) 2022**.

(2) Perintah ini mula berkuat kuasa pada 26 April 2022.

**Barang-barang kawalan**

2. Barang-barang yang dinyatakan dalam Jadual diisytiharkan sebagai barang-barang kawalan bagi tempoh mulai 26 April 2022 hingga 6 Mei 2022.

1. Daging lembu tempatan (kecuali bahagian batang pinang)
2. Daging lembu import
3. Daging kerbau import (India)
4. Cili merah
5. Tomato
6. Timun
7. Kubis bulat import (Indonesia dan China, tidak termasuk kubis Beijing)
8. Kacang panjang
9. Terung panjang
10. Halia tua import
11. Ikan kembung termasuk ikan mabung (berat antara 8 ekor hingga 12 ekor sekilogram)
12. Ikan selayang (berat antara 8 ekor hingga 12 ekor sekilogram)

13. Ikan aya atau tongkol (berat antara 1 ekor hingga 2 ekor sekilogram)
14. Ikan demuduk, sagai, cermin atau cupak

CONTROL OF SUPPLIES ACT 1961

CONTROL OF SUPPLIES (CONTROLLED ARTICLES) (NO. 2) ORDER 2022

IN exercise of the powers conferred by section 5 of the Control of Supplies Act 1961 [Act 122], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Control of Supplies (Controlled Articles) (No.2) Order 2022**.

(2) This Order comes into operation on 26 April 2022.

**Controlled articles**

2. The articles specified in the Schedule are declared to be controlled articles for the period from 26 April 2022 to 6 May 2022.

SCHEDULE

CONTROLLED ARTICLES

1. Local beef (not including tenderloin)
2. Imported beef
3. Imported buffalo meat (India)
4. Red chilli
5. Tomato
6. Cucumber
7. Imported round cabbage (Indonesia and China, not including Beijing cabbage)
8. Long bean
9. Long eggplant
10. Imported old ginger
11. Indian mackerel (weight ranges between 8 fishes to 12 fishes per kilogram)
12. Scad (weight ranges between 8 fishes to 12 fishes per kilogram)

13. Tuna (weight ranges between 1 fish to 2 fishes per kilogram)
14. Malabar trevally
