AKTA KUMPULAN WANG SIMPANAN PEKERJA 1991

PERATURAN-PERATURAN KUMPULAN WANG SIMPANAN PEKERJA (PINDAAN) 2022

PADA menjalankan kuasa yang diberikan oleh seksyen 71 Akta Kumpulan Wang Simpanan Pekerja 1991 [*Akta 452*], Menteri, atas syor Lembaga, membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Kumpulan Wang Simpanan Pekerja (Pindaan) 2022**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 15 April 2022.

Pindaan peraturan 5A

2. Peraturan-Peraturan Kumpulan Wang Simpanan Pekerja 2001 [*P.U. (A) 409/2001*] dipinda dalam peraturan 5A dengan memasukkan selepas subperaturan (2A) subperaturan yang berikut:

“(2B) Jika Lembaga membenarkan seseorang ahli untuk membuat suatu pengeluaran di bawah perenggan 54(6)(*n*) Akta, Lembaga hendaklah mengkreditkan ke dalam Akaun I ahli itu apa-apa caruman atau wang yang dibayar ke dalam akaun ahli itu yang bersamaan dengan—

(*a*) amaun wang yang dikeluarkan di bawah perenggan 54(6)(*n*) Akta; dan

(*b*) amaun tambahan sebanyak dua puluh peratus daripada amaun wang yang dikeluarkan di bawah perenggan 54(6)(*n*) Akta.”.

EMPLOYEES PROVIDENT FUND ACT 1991

EMPLOYEES PROVIDENT FUND (AMENDMENT) REGULATIONS 2022

IN exercise of the powers conferred by section 71 of the Employees Provident Fund Act 1991 [*Act 452*], the Minister, on the recommendation of the Board, makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Employees Provident Fund (Amendment) Regulations 2022**.

(2) These Regulations come into operation on 15 April 2022.

Amendment of regulation 5A

2. The Employees Provident Fund Regulations 2001 [*P.U. (A) 409/2001*] are amended in regulation 5A by inserting after subregulation (2A) the following subregulation:

“(2B) Where the Board authorizes a member to make a withdrawal under paragraph 54(6)(n) of the Act, the Board shall credit into Account I of the member any contribution or money paid into the account of the member which is equivalent to—

(a) the amount withdrawn under paragraph 54(6)(n) of the Act;
and

(b) the additional amount of twenty percent of the amount withdrawn under paragraph 54(6)(n) of the Act.”.
