PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 6) 2022

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [*Akta 376*], Menteri, setelah berunding dengan Kerajaan Negeri Pahang, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 6) 2022**.

(2) Perintah ini mula berkuat kuasa pada 15 April 2022.

Pindaan Jadual Pertama

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [*P.U. (A) 401/1989*] dipinda dalam Jadual Pertama di bawah kepala "**Negeri Pahang Darul Makmur**"—

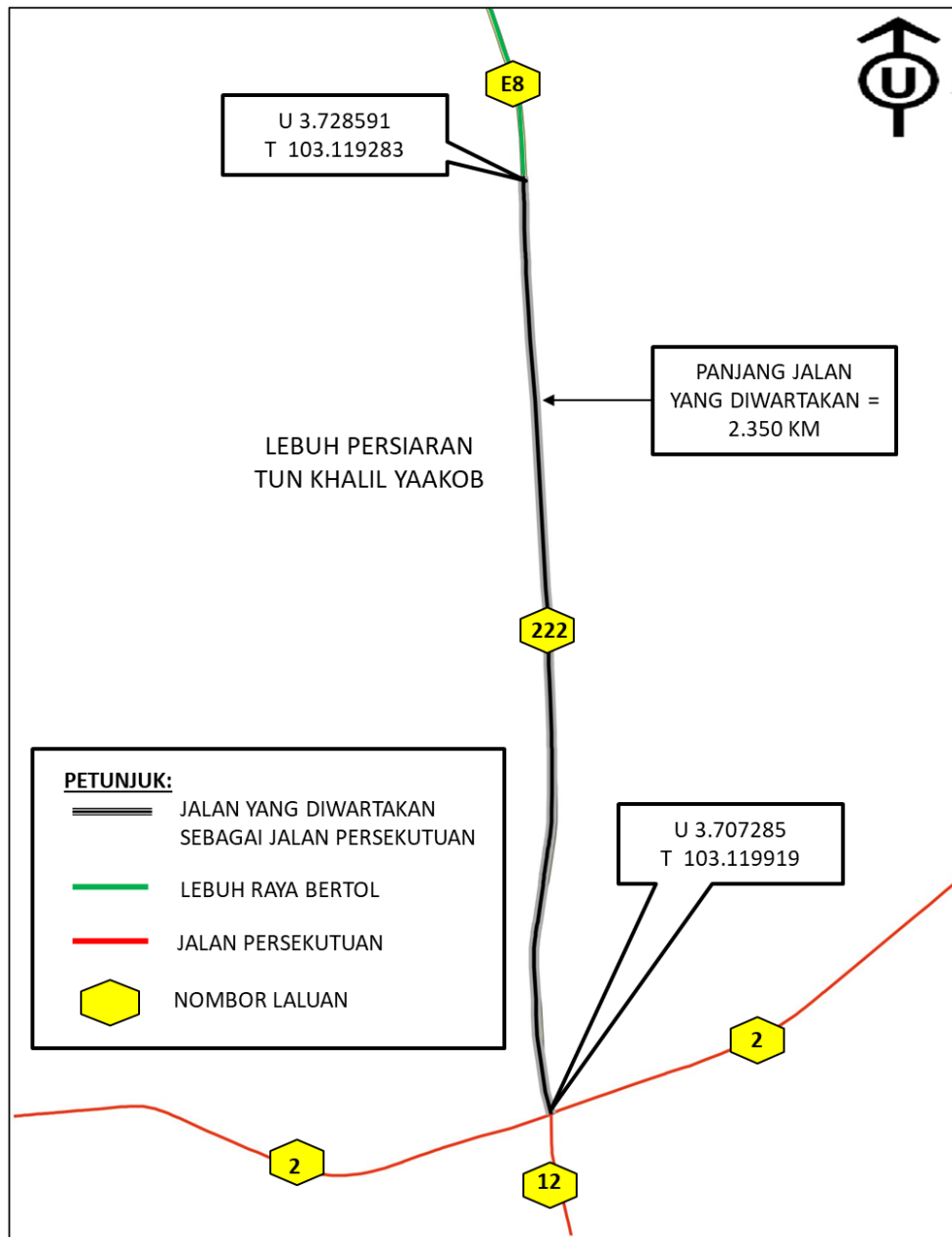
(a) dengan menggantikan butiran 29 dengan butiran yang berikut:

"29. (*Laluan 222*): *Lebuh Persiaran Tun Khalil Yaakob*

Dari persimpangan Laluan 2 di koordinat U 3.707285, T 103.119919 dan berakhir di sempadan E8, Lebuh Raya Pantai Timur 1 di koordinat U 3.728591, T 103.119283 di dalam sempadan hak lalu-lalang sebagaimana yang ditunjukkan dalam PETA 7: LEBUH PERSIARAN TUN KHALIL YAAKOB (jarak sepanjang 2.350 km)."; dan

(b) dengan menggantikan PETA 7: NEGERI PAHANG dengan peta yang berikut:

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 6) ORDER 2022

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Pahang, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 6) Order 2022**.

(2) This Order comes into operation on 15 April 2022.

Amendment of First Schedule

2. The Federal Roads (West Malaysia) Order 1989 [P.U. (A) 401/1989] is amended in the First Schedule under the heading of “**Negeri Pahang Darul Makmur**”—

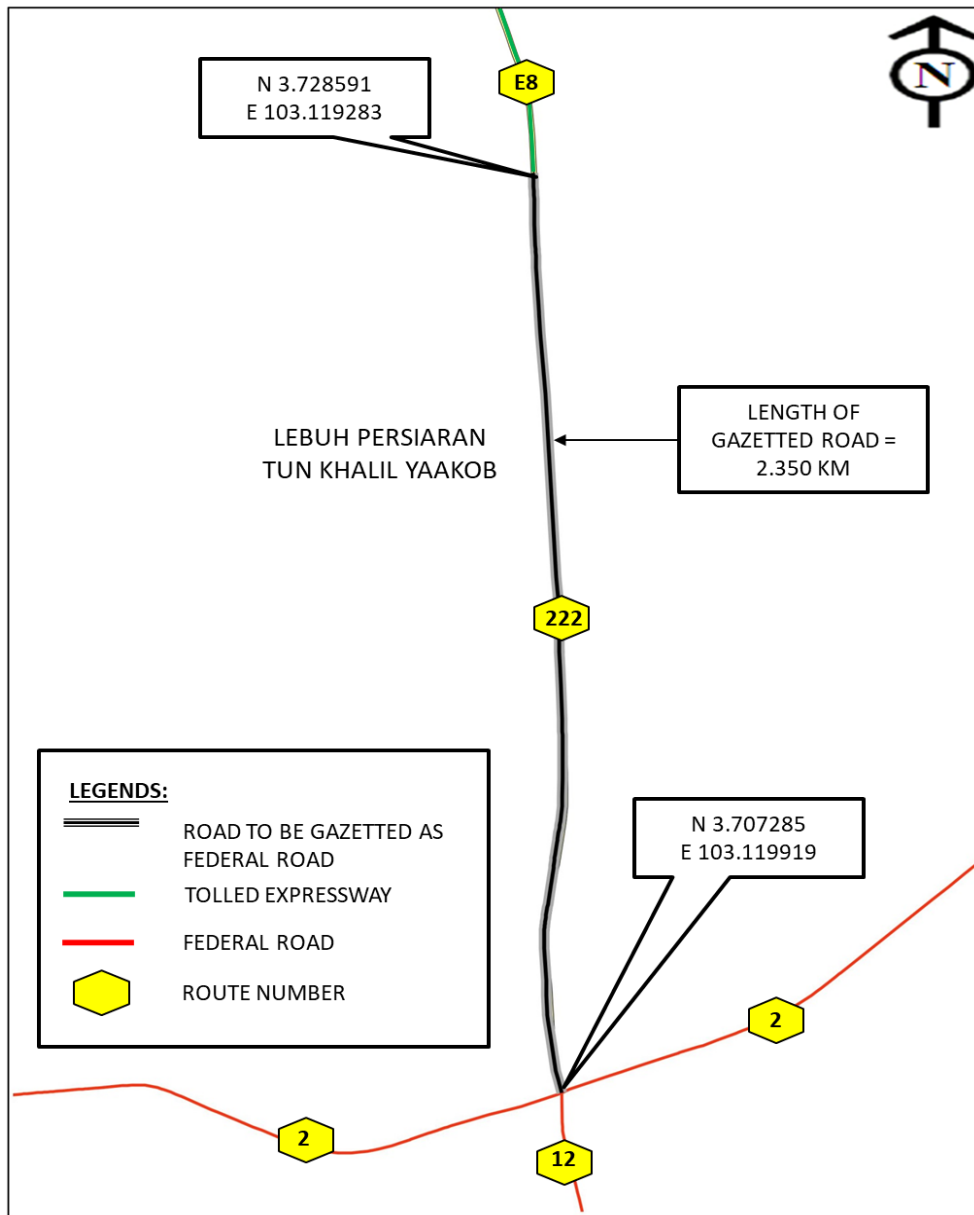
(a) by substituting for item 29 the following item:

“29. (Route 222): *Lebuhraya Persiaran Tun Khalil Yaakob*

From the junction of Route 2 at coordinates N 3.707285, E 103.119919 and ending at E8, East Coast Expressway 1 boundary at coordinates N 3.728591, E 103.119283 within the boundaries of right of way as shown on MAP 7: LEBUHRAYA PERSIARAN TUN KHALIL YAAKOB (a distance of 2.350 km).”; and

(b) by substituting for MAP 7: NEGERI PAHANG the following map:
