AKTA KASTAM 1967

PERINTAH DUTI KASTAM (PENGECCUALIAN) 2017 (PINDAAN) (NO. 2) 2022

PADA menjalankan kuasa yang diberikan oleh subseksyen 14(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Duti Kastam (Pengeccualian) 2017 (Pindaan) (No. 2) 2022**.

(2) Perintah ini mula berkuat kuasa pada 1 April 2022.

**Pindaan Jadual**

2. Perintah Duti Kastam (Pengeccualian) 2017 [*P.U. (A) 445/2017*] dipinda dalam Bahagian I Jadual, berhubung dengan butiran 76, dalam ruang (3)—

(a) dengan memasukkan di hujung perenggan (xxii) koma bernoktah; dan

(b) dengan memasukkan selepas perenggan (xxii) perenggan yang berikut:

“(xxiii) produk ikan pari kering”.

CUSTOMS ACT 1967

CUSTOMS DUTIES (EXEMPTION) 2017 (AMENDMENT) (NO. 2) ORDER 2022

IN exercise of the powers conferred by subsection 14(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs Duties (Exemption) 2017 (Amendment) (No. 2) Order 2022**.

(2) This Order comes into operation on 1 April 2022.

**Amendment of Schedule**

2. The Customs Duties (Exemption) Order 2017 [P.U. (A) 445/2017] is amended in Part I of the Schedule, in relation to item 76, in column (3)—

(a) by inserting at the end of paragraph (xxii) a semi colon; and

(b) by inserting after paragraph (xxii) the following paragraph:

“(xxiii) dried stingray products”.
