INCOME TAX (EXEMPTION) (NO. 12) 2018 (AMENDMENT) ORDER 2022

IN exercise of the powers conferred by paragraph 127(3)(b) of the Income Tax Act 1967 [Act 53], the Minister makes the following order:

**Citation**

1. This order may be cited as the **Income Tax (Exemption) (No. 12) 2018 (Amendment) Order 2022**.

**Amendment of paragraph 4**

2. The Income Tax (Exemption) (No. 12) 2018 [P.U. (A) 391/2018] is amended in subparagraph 4(3) by substituting for the word “2020” the word “2022”.
