AKTA PROFESION UNDANG-UNDANG 1976

KAEDAH-KAEDAH PROFESION UNDANG-UNDANG
(PROSIDING TATATERTIB) (PINDAAN) 2022

PADA menjalankan kuasa yang diberikan oleh seksyen 103F Akta Profesion Undang-Undang 1976 [*Akta 166*], Lembaga Tatatertib membuat kaedah-kaedah yang berikut:

Nama

1. Kaedah-kaedah ini bolehlah dinamakan **Kaedah-Kaedah Profesion Undang-Undang (Prosiding Tatatertib) (Pindaan) 2022**.

Pindaan kaedah 13

2. Kaedah-Kaedah Profesion Undang-Undang (Prosiding Tatatertib) 2017 [*P.U. (A) 197/2017*] dipinda dengan menggantikan kaedah 13 dengan kaedah yang berikut:

“Masa dan tempat pendengaran Jawatankuasa Tatatertib

13. (1) Jawatankuasa Tatatertib hendaklah menjalankan prosidingnya pada tarikh, masa dan di tempat yang ditetapkan oleh Pengerusi Jawatankuasa Tatatertib.

(2) Apa-apa prosiding yang diadakan menurut subkaedah (1) boleh diadakan melalui suatu rangkaian video secara langsung, rangkaian televisyen secara langsung atau apa-apa cara komunikasi elektronik yang lain.

(3) Bagi tujuan kaedah ini, rujukan kepada “tempat” adalah termasuk ruang siber, tempat maya atau ruang maya.”

LEGAL PROFESSION ACT 1976

LEGAL PROFESSION (DISCIPLINARY PROCEEDINGS)
(AMENDMENT) RULES 2022

IN exercise of the powers conferred by section 103F of the Legal Profession Act 1976 [Act 166], the Disciplinary Board makes the following rules:

Citation

1. These rules may be cited as the **Legal Profession (Disciplinary Proceedings) (Amendment) Rules 2022**.

Amendment of rule 13

2. The Legal Profession (Disciplinary Proceedings) Rules 2017 [P.U. (A) 197/2017] are amended by substituting for rule 13 the following rule:

“Time and place of Disciplinary Committee hearing

13. (1) The Disciplinary Committee shall conduct its proceedings on such date and at such time and place as the Chairman of the Disciplinary Committee may appoint.

(2) Any proceeding held pursuant to subrule (1) may be held through live video link, live television link or any other electronic means of communication.

(3) For purposes of this rule, reference to “place” includes cyberspace, virtual place or virtual space.”.
