AKTA PROFESION UNDANG-UNDANG 1976

KAEDAH-KAEDAH PROFESION UNDANG-UNDANG
(LEMBAGA TATATERTIB) (PROSEDUR) (PINDAAN) 2022

PADA menjalankan kuasa yang diberikan oleh subseksyen 93(6) Akta Profesion Undang-Undang 1976 [*Akta 166*], Lembaga Tatatertib membuat kaedah-kaedah yang berikut:

Nama

1. Kaedah-kaedah ini bolehlah dinamakan **Kaedah-Kaedah Profesion Undang-Undang (Lembaga Tatatertib) (Prosedur) (Pindaan) 2022**.

Pindaan kaedah 2

2. Kaedah-Kaedah Profesion Undang-Undang (Lembaga Tatatertib) (Prosedur) 1994 [*P.U. (A) 191/1994*], yang disebut “Kaedah-Kaedah ibu” dalam Kaedah-Kaedah ini, dipinda dalam kaedah 2—

(a) dengan menomborkan semula kaedah sedia ada sebagai subkaedah (1); dan

(b) dengan memasukkan selepas subkaedah (1) yang dinomborkan semula subkaedah yang berikut:

“(2) Apa-apa mesyuarat yang diadakan menurut subkaedah (1) boleh diadakan melalui suatu rangkaian video secara langsung, rangkaian televisyen secara langsung atau apa-apa cara komunikasi elektronik yang lain.

(3) Bagi tujuan kaedah ini, rujukan kepada “tempat” adalah termasuk ruang siber, tempat maya atau ruang maya.”.

Pindaan kaedah 7

3. Kaedah 7 Kaedah-Kaedah ibu dipinda dengan menggantikan perkataan “buku” di mana-mana jua terdapat dengan perkataan “dokumen”.

LEGAL PROFESSION ACT 1976

LEGAL PROFESSION (DISCIPLINARY BOARD) (PROCEDURE)
(AMENDMENT) RULES 2022

IN exercise of the powers conferred by subsection 93(6) of the Legal Profession Act 1976 [*Act 166*], the Disciplinary Board makes the following rules:

Citation

1. These rules may be cited as the **Legal Profession (Disciplinary Board) (Procedure) (Amendment) Rules 2022**.

Amendment of rule 2

2. The Legal Profession (Disciplinary Board) (Procedure) Rules 1994 [*P.U. (A) 191/1994*], which are referred to as “the principal Rules” in these Rules, are amended in rule 2—

(a) by renumbering the existing rule as subrule (1); and

(b) by inserting after subrule (1) as renumbered the following subrules:

“(2) Any meeting held pursuant to subrule (1) may be held through live video link, live television link or any other electronic means of communication.

(3) For purposes of this rule, reference to “place” includes cyberspace, virtual place or virtual space.”.

Amendment of rule 7

3. Rule 7 of the principal Rules is amended by substituting for the word “book” wherever appearing the word “document”.
