AKTA JALAN PERSEKUTUAN 1959

PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 4) 2022

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [*Akta 376*], Menteri, setelah berunding dengan Kerajaan Negeri Kelantan, membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 4) 2022**.

(2) Perintah ini mula berkuat kuasa pada 15 Mac 2022.

**Pindaan Jadual Pertama**

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [*P.U. (A) 401/1989*] dipinda dalam Jadual Pertama di bawah kepala "**Negeri Kelantan Darul Naim**"—

(a) dengan menggantikan butiran 8 dengan butiran yang berikut:

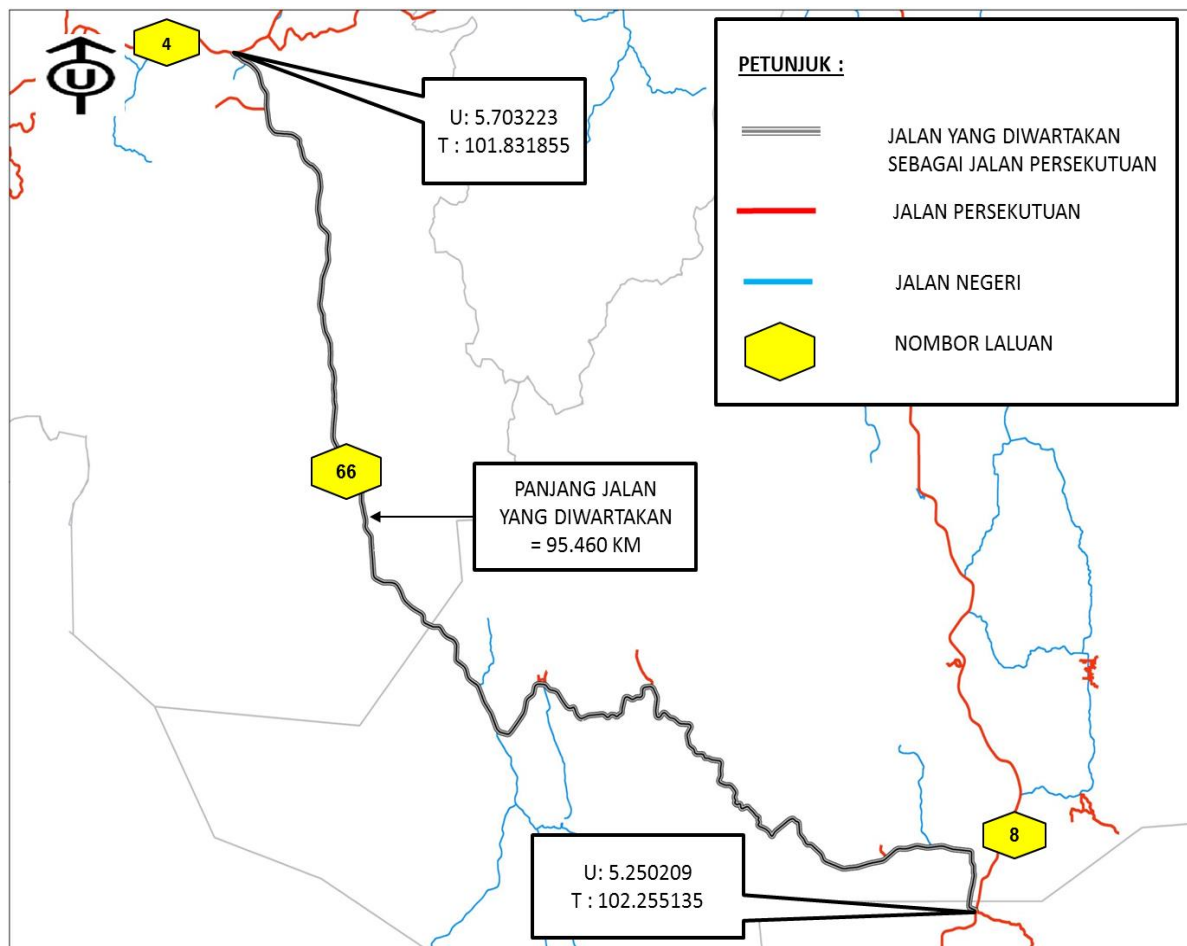
"8. (*Laluan 66*): *Jalan Kg. Sungai Sam-Jeli*

Bermula dari persimpangan Laluan 8, Jalan Kota Bharu–Gua Musang di koordinat U 5.250209, T 102.255135 dan berakhir di persimpangan Laluan 4, Jalan Pasir Puteh–Gerik di koordinat U 5.703223, T 101.831855 di dalam sempadan hak lalu-lalang sebagaimana yang ditunjukkan dalam PETA 4: JALAN KG. SUNGAI SAM-JELI (jarak sepanjang 95.460 km).";

(b) dengan memotong butiran 26; dan

(c) dengan menggantikan PETA 4: JALAN PERSEKUTUAN NEGERI KELANTAN dengan peta yang berikut:

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 4) ORDER 2022

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Kelantan, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 4) Order 2022**.

(2) This Order comes into operation on 15 March 2022.

**Amendment of First Schedule**

2. The Federal Roads (West Malaysia) Order 1989 [P.U. (A) 401/1989] is amended in the First Schedule under the heading of “**Negeri Kelantan Darul Naim**”—

(a) by substituting for item 8 the following item:

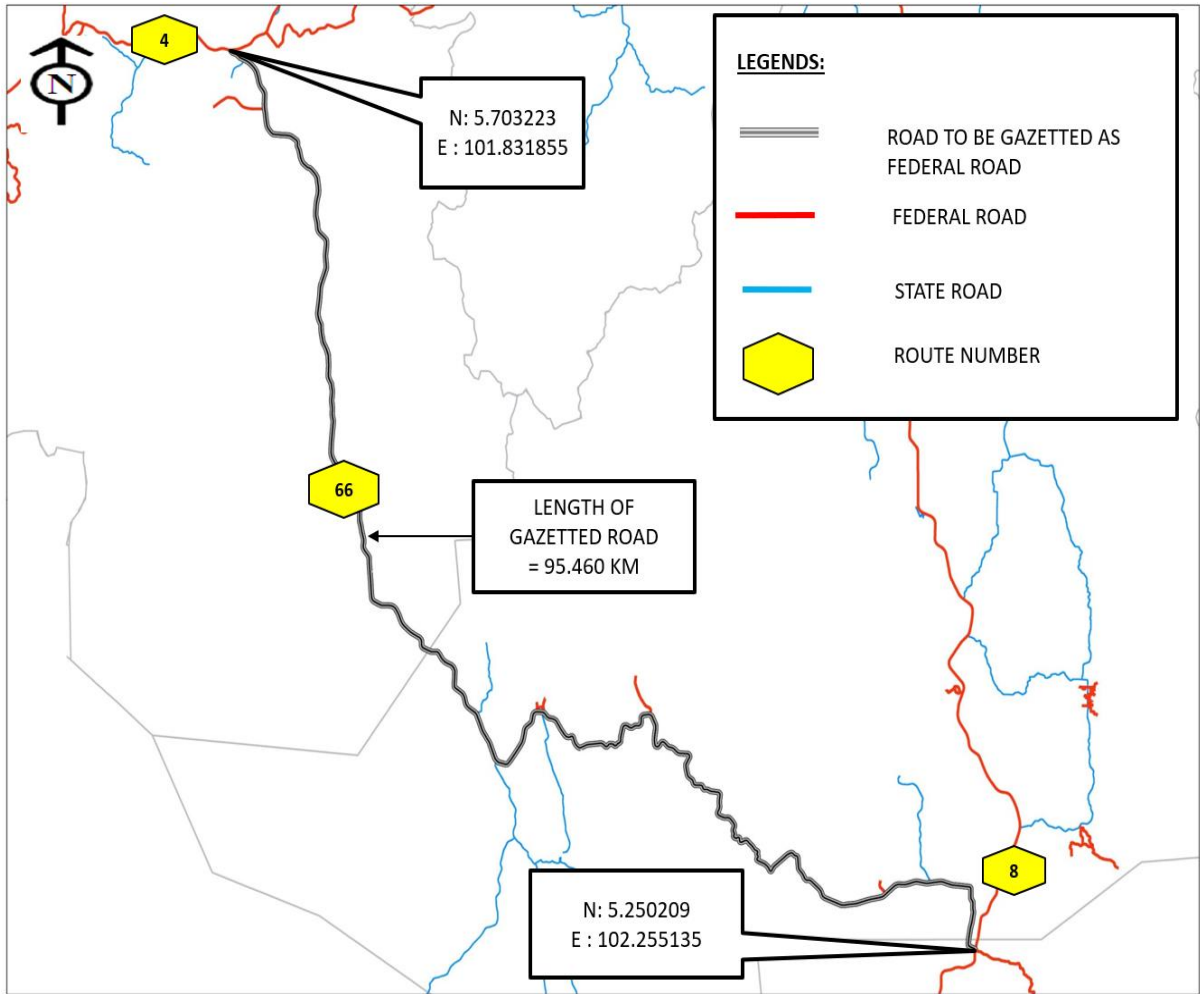
“8. *(Route 66): Kg. Sungai Sam–Jeli Road*

Starting from the junction of Route 8, Kota Bharu–Gua Musang Road at coordinates N 5.250209, E 102.255135 and ending at the junction of Route 4, Pasir Puteh–Gerik Road at coordinates N 5.703223, E 101.831855 within the boundaries of right of way as shown on MAP 4: KG. SUNGAI SAM-JELI ROAD (a distance of 95.460 km).”;

(b) by deleting item 26; and

(c) by substituting for MAP 4: KELANTAN STATE FEDERAL ROAD the following map:
