PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 3) 2022

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [*Akta 376*], Menteri, setelah berunding dengan Kerajaan Negeri Pahang, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 3) 2022**.

(2) Perintah ini mula berkuat kuasa pada 28 Februari 2022.

Pindaan Jadual Pertama

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [*P.U. (A) 401/1989*] dipinda dalam Jadual Pertama di bawah kepala "**Negeri Pahang Darul Makmur**"—

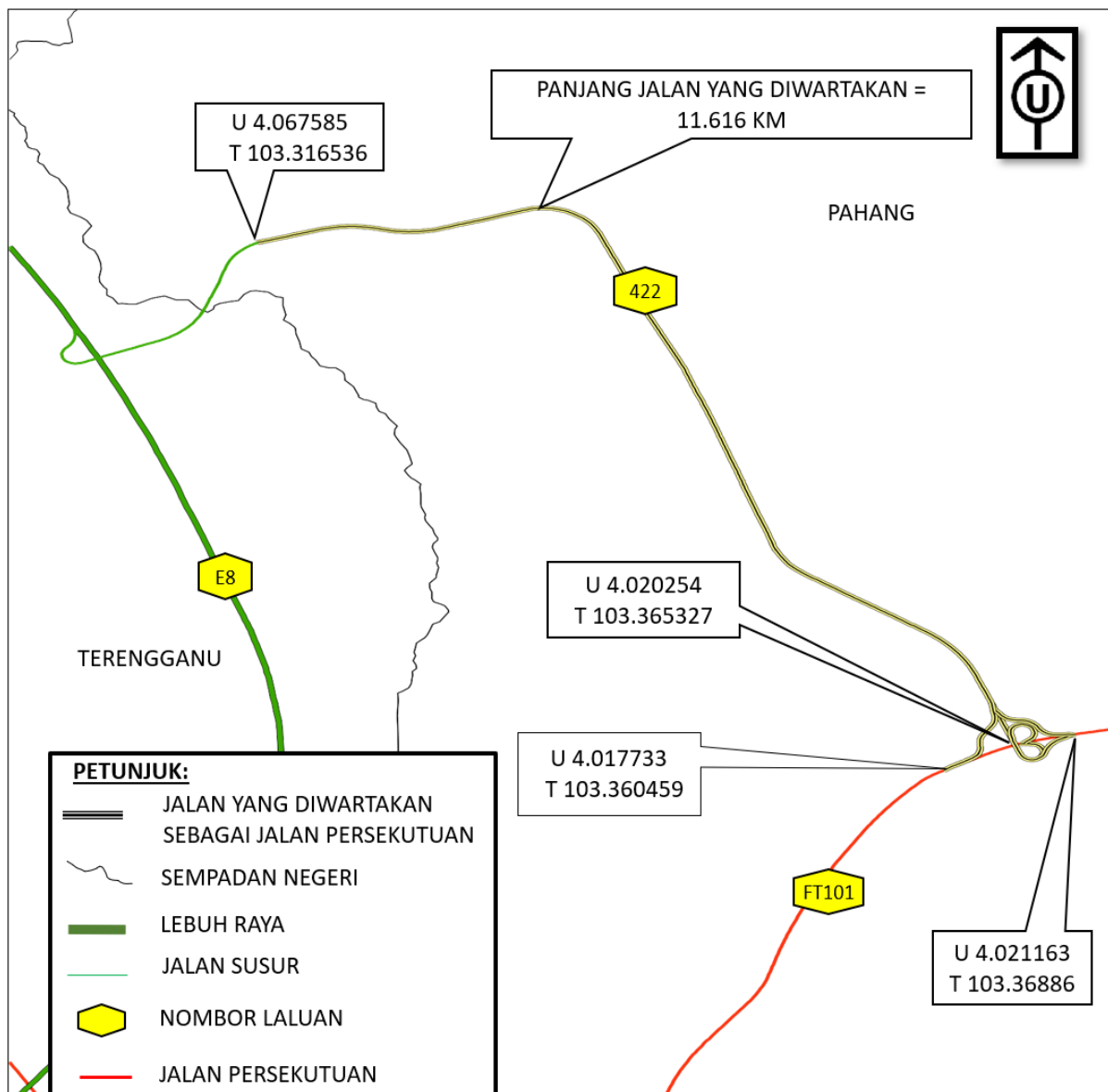
(a) dengan memasukkan selepas butiran 50 butiran yang berikut:

"51. (*Laluan 422*): *Persiaran Pelabuhan Kuantan*

Bermula dari jalan susur di Lebu Raya Pantai Timur 1 di koordinat U 4.067585, T 103.316536 dan berakhir di persimpangan Laluan 101, Jalan Pintasan Gebeng di koordinat U 4.020254, T 103.365327, U 4.017733, T 103.360459 dan U 4.021163, T 103.36886 di dalam sempadan hak lalu-lalang sebagaimana yang ditunjukkan dalam PETA 31: PERSIARAN PELABUHAN KUANTAN (jarak sepanjang 11.616 km)."; dan

(b) dengan memasukkan selepas PETA 30: JALAN TEMERLOH–KEMAYAN, NEGERI PAHANG peta yang berikut:

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 3) ORDER 2022

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Pahang, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 3) Order 2022**.

(2) This Order comes into operation on 28 February 2022.

Amendment of First Schedule

2. The Federal Roads (West Malaysia) Order 1989 [P.U. (A) 401/1989] is amended in the First Schedule under the heading of “**Negeri Pahang Darul Makmur**”—

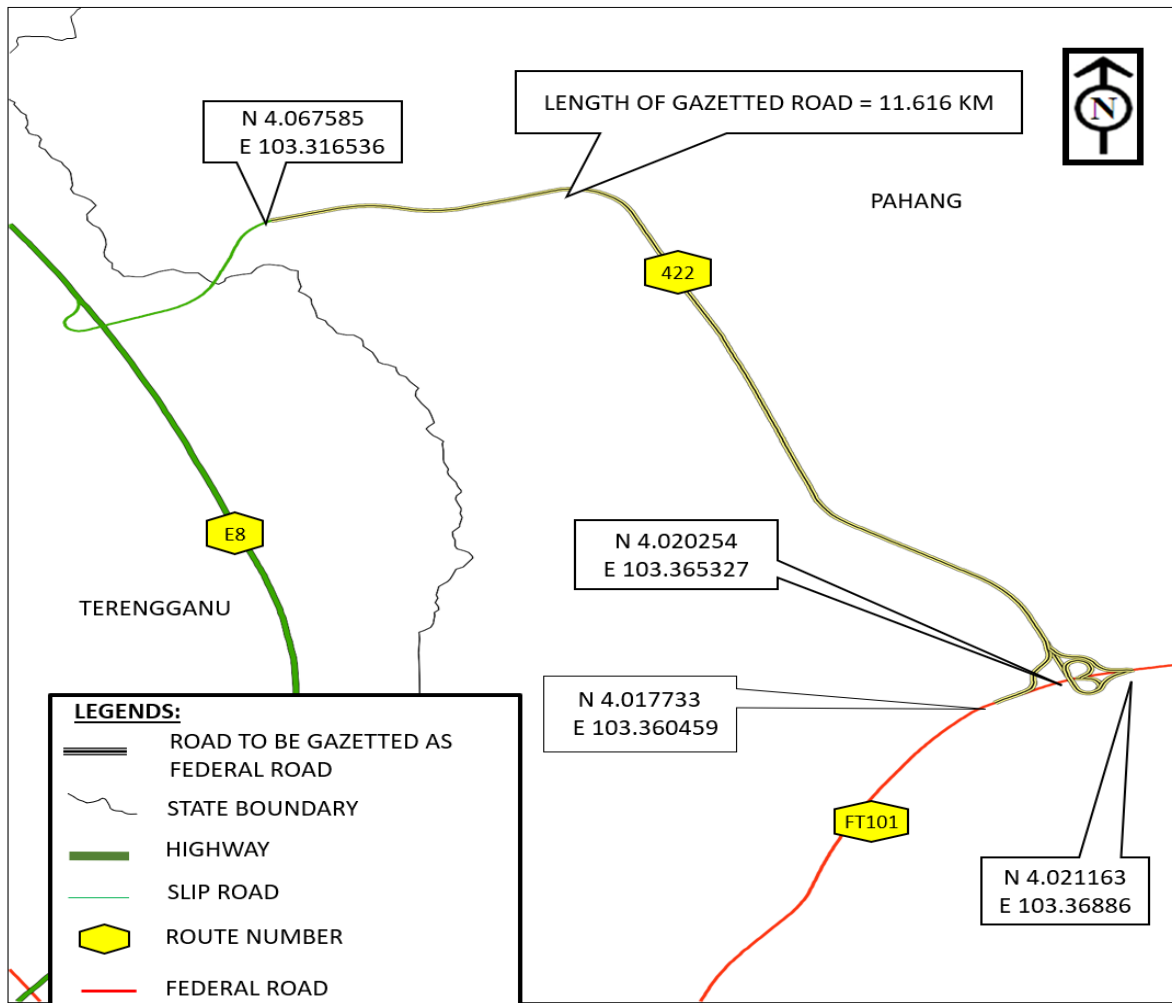
(a) by inserting after item 50 the following item:

“51. *(Route 422): Kuantan Port Promenade*

Starting from slip road at East Coast Highway 1 at coordinates N 4.067585, E 103.316536 and ending at junction of Route 101, Gebeng Bypass Road at coordinates N 4.020254, E 103.365327, N 4.017733, E 103.360459 and N 4.021163, E 103.36886 within the boundaries of right of way as shown on MAP 31: KUANTAN PORT PROMENADE (a distance of 11.616 km).”; and

(b) by inserting after MAP 30: TEMERLOH–KEMAYAN ROAD, NEGERI PAHANG the following map:
