AKTA JALAN PERSEKUTUAN 1959

PERINTAH JALAN PERSEKUTUAN (SARAWAK) (PINDAAN) 2022

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Sarawak, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Sarawak) (Pindaan) 2022**.

(2) Perintah ini mula berkuat kuasa pada 10 Januari 2022.

Pindaan Jadual Pertama

2. Perintah Jalan Persekutuan (Sarawak) 1996 [P.U. (A) 551/1996] yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam Jadual Pertama di bawah kepala “LEBUH RAYA PAN BORNEO” dengan memasukkan selepas butiran (j*b*) butiran yang berikut:

“(j*c*) (Laluan 1): *Bulatan Serian–Jambatan Sungai Kerang*

Bermula di koordinat U 1.183414, T 110.564475 dan berakhir di koordinat U 1.048421, T 110.762922 di dalam sempadan hak lalu-lalang sebagaimana yang ditunjukkan dalam PETA BULATAN SERIAN–JAMBATAN SUNGAI KERANG (jarak sepanjang 33.000 km).

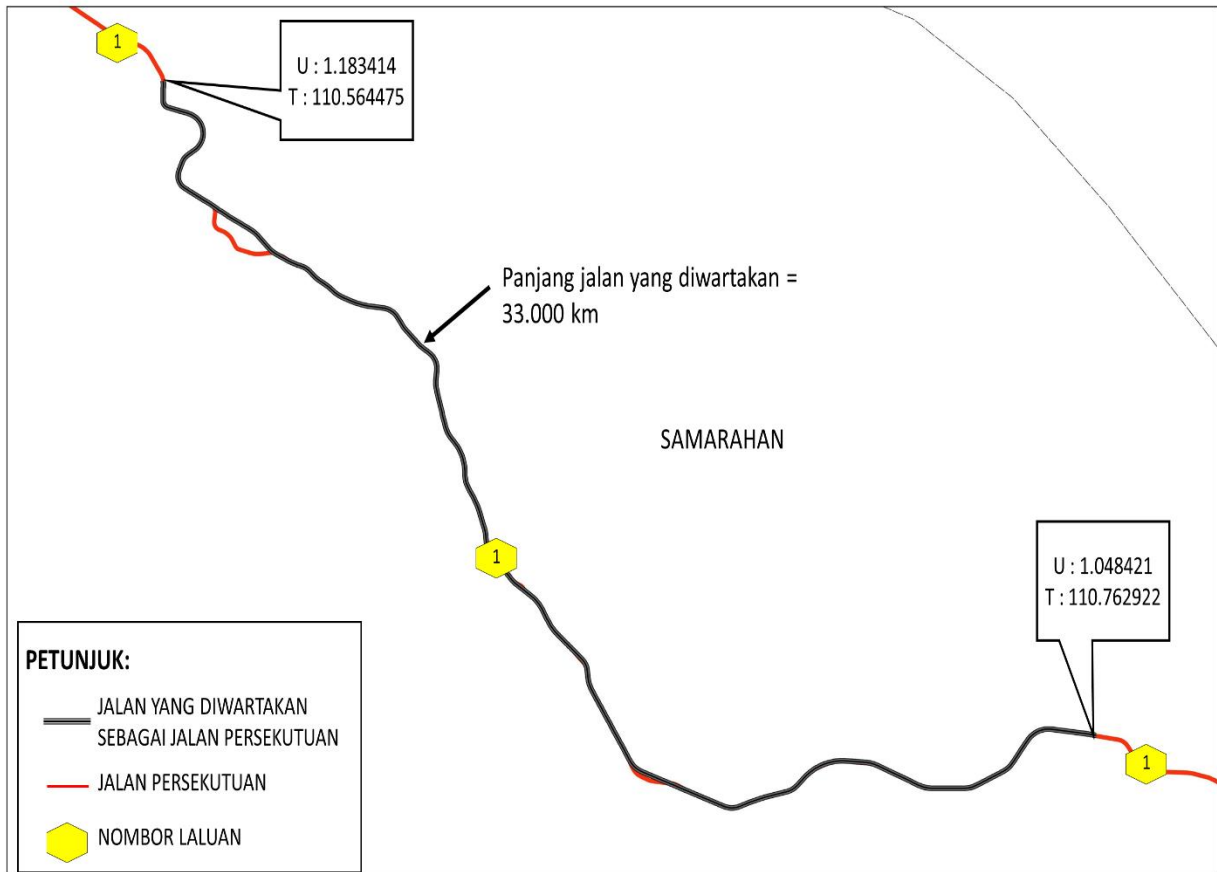
(j*d*) (Laluan 1): *Persimpangan Bintangor–Jambatan Sungai Jikang*

Bermula di koordinat U 2.066985, T 111.668248 dan berakhir di koordinat U 2.058944, T 111.911380 di dalam sempadan hak lalu-lalang sebagaimana yang ditunjukkan dalam PETA PERSIMPANGAN BINTANGOR–JAMBATAN SUNGAI JIKANG (jarak sepanjang 29.000 km).”.

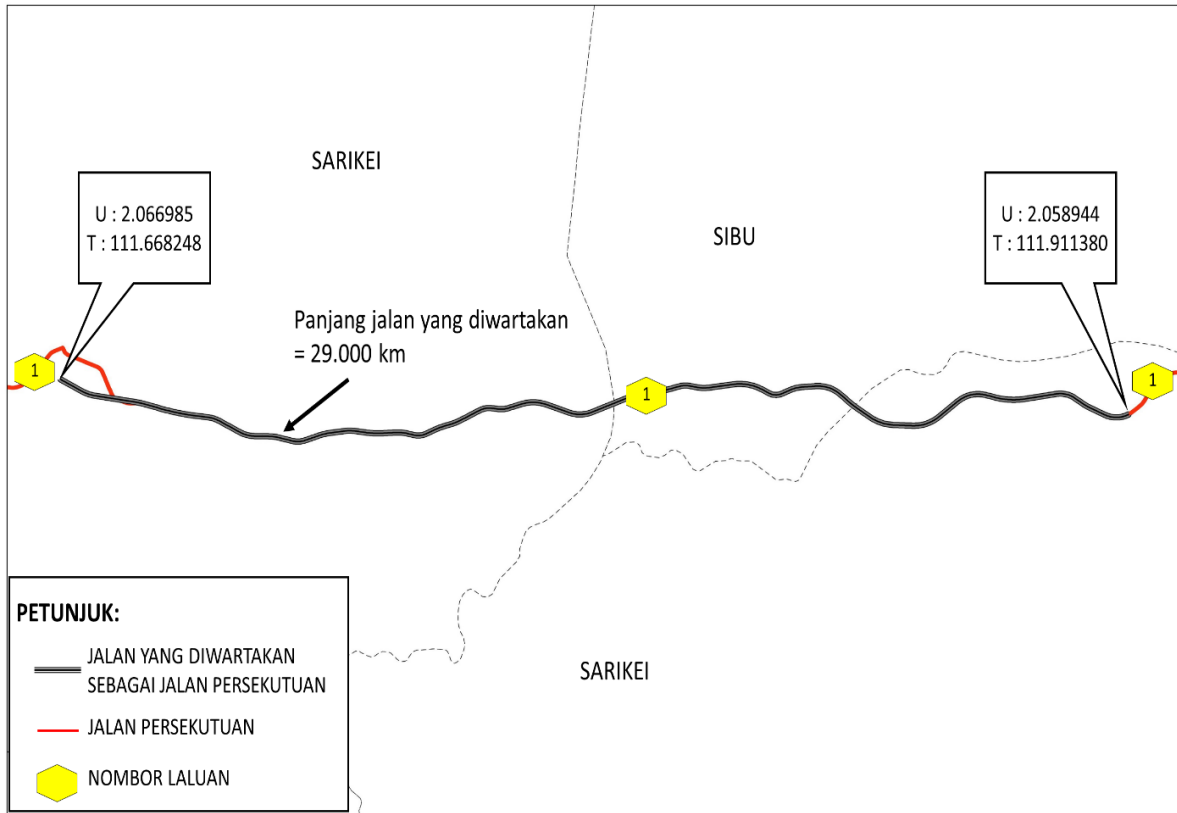
Pindaan Jadual Ketiga

FEDERAL ROADS ACT 1959

FEDERAL ROADS (SARAWAK) (AMENDMENT) ORDER 2022

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Sarawak, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Sarawak) (Amendment) Order 2022**.

(2) This Order comes into operation on 10 January 2022.

Amendment of First Schedule

2. The Federal Roads (Sarawak) Order 1996 [*P.U. (A) 551/1996*] which is referred to as the “principal Order” in this Order, is amended in the First Schedule under the heading “PAN BORNEO HIGHWAY” by inserting after item *(jb)* the following items:

“(jc) (Route 1): Serian Roundabout–Sungai Kerang Bridge

Starting at coordinates N 1.183414, E 110.564475 and ending at coordinates N 1.048421, E 110.762922 within the boundaries of right of way as shown on MAP OF SERIAN ROUNDABOUT–SUNGAI KERANG BRIDGE (a distance of 33.000 km).

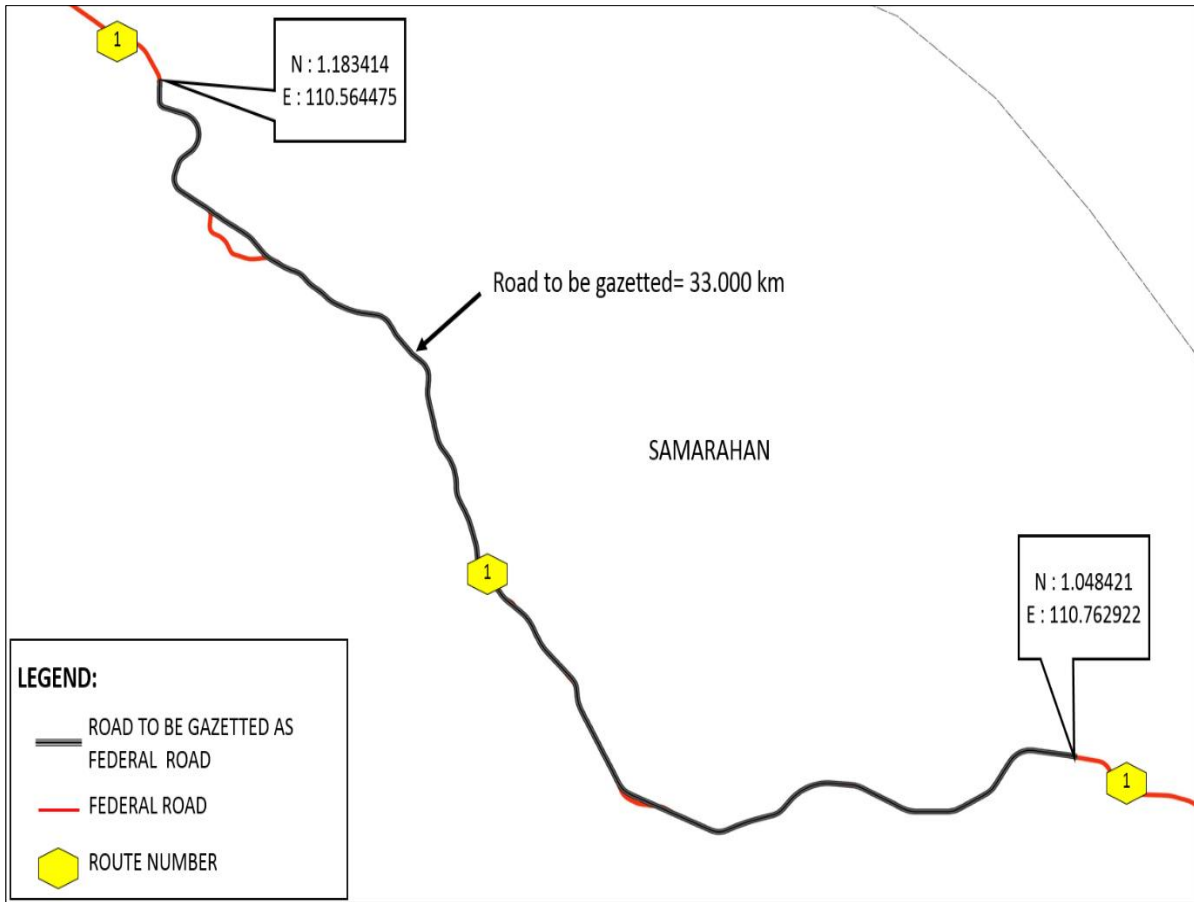
(jd) (Route 1): Bintangor Intersection–Sungai Jikang Bridge

Starting at coordinates N 2.066985, E 111.668248 and ending at coordinates N 2.058944, E 111.911380 within the boundaries of right of way as shown on MAP OF BINTANGOR INTERSECTION–SUNGAI JIKANG BRIDGE (a distance of 29.000 km).”.

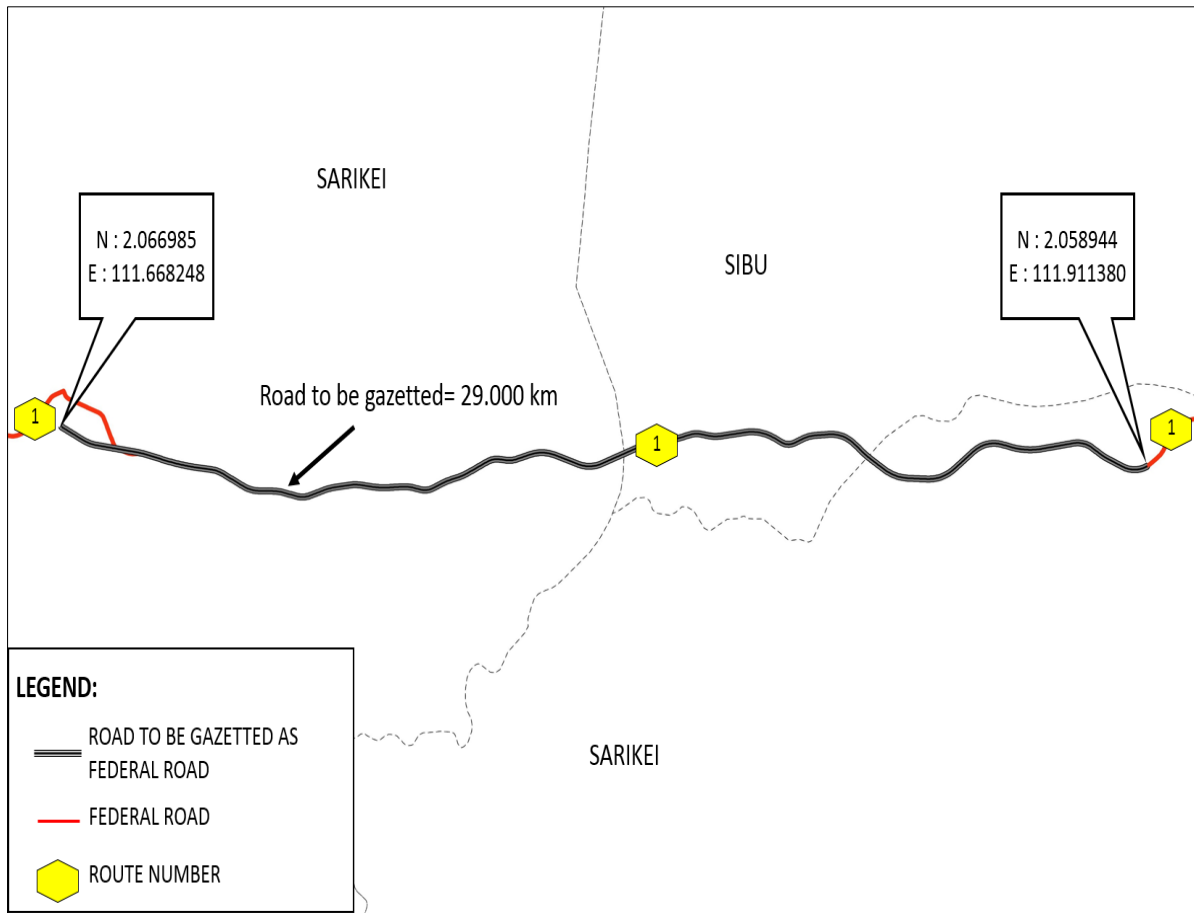
Amendment of Third Schedule

3. The principal Order is amended in the Third Schedule by inserting after MAP OF NYABAU ROAD-BAKUN ROAD INTERSECTION the following maps:
