REGISTRATION OF PHARMACISTS (AMENDMENT OF FIRST SCHEDULE)
(REVOCATION) ORDER 2021

IN exercise of the powers conferred by subsection 6(3) of the Registration of Pharmacists Act 1951 [*Act 371*], the Minister, after consulting the Board, makes the following order:

Citation and commencement
