## PERINTAH FI (PASPORT DAN VISA) (PINDAAN) 2021

## FEES ACT 1951

## FEES (PASSPORTS AND VISAS) (AMENDMENT) ORDER 2021

IN exercise of the powers conferred by section 3 of the Fees Act 1951 [*Act 209*], the Yang di-Pertuan Agong makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Fees (Passports and Visas) (Amendment) Order 2021**.

(2) This Order comes into operation on 17 November 2021.

**Amendment of paragraph 2**

2. The Fees (Passports and Visas) Order 1967 [*P.U. 189/1967*] is amended in paragraph 2 by inserting after subitem II(*e*) and the particulars relating to it the following subitem and particulars:
