PERINTAH KAWALAN BEKALAN (BARANG-BARANG KAWALAN) (NO. 5) 2021

PADA menjalankan kuasa yang diberikan oleh seksyen 5 Akta Kawalan Bekalan 1961 [*Akta 122*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Kawalan Bekalan (Barang-Barang Kawalan) (No. 5) 2021**.

(2) Perintah ini mula berkuat kuasa pada 1 November 2021.

CONTROL OF SUPPLIES ACT 1961

CONTROL OF SUPPLIES (CONTROLLED ARTICLES) (NO. 5) ORDER 2021

IN exercise of the powers conferred by section 5 of the Control of Supplies Act 1961 [*Act 122*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Control of Supplies (Controlled Articles) (No. 5) Order 2021**.

(2) This Order comes into operation on 1 November 2021.

**Controlled articles**

2. The articles specified in the Schedule are declared to be controlled articles for the period from 1 November 2021 to 7 November 2021.
