AKTA KAWALAN BEKALAN 1961

PERINTAH KAWALAN BEKALAN (PENGECUALIAN) (PINDAAN) 2021

PADA menjalankan kuasa yang diberikan oleh seksyen 5A Akta Kawalan Bekalan 1961 [Akta 122], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kawalan Bekalan (Pengecualian) (Pindaan) 2021**.

(2) Perintah ini mula berkuat kuasa pada 15 Oktober 2021.

Pindaan perenggan 5

2. Perintah Kawalan Bekalan 1991 [P.U. (A) 77/1991], yang disebut "Perintah ibu" dalam Perintah ini, dipinda dengan menggantikan perenggan 5 dengan perenggan yang berikut:

"Pengecualian daripada 5. Mana-mana orang yang dalam apa-apa perjalanan peraturan 18, Peraturan-peraturan Kawalan Bekalan 1974. perdagangan atau perniagaan membeli barang berjadual yang dinyatakan dalam ruang (1) Jadual Ketiga daripada penjual atau pembekal yang dinyatakan dalam ruang (2) bagi kegunaan yang dinyatakan dalam ruang (3) dikecualikan daripada pemakaian peraturan 18 Peraturan-Peraturan Kawalan Bekalan 1974."

Penggantian Jadual Ketiga

3. Perintah ibu dipinda dengan menggantikan Jadual Ketiga dengan jadual yang berikut:

“JADUAL KETIGA
(Perenggan 5)

(1) <i>Barang berjadual</i>	(2) <i>Penjual/Pembekal</i>	(3) <i>Kegunaan</i>
1. Semua gred petrol	Stesen minyak	Mengisi tangki minyak asal kenderaan bagi maksud menjalankan fungsi kenderaan itu
2. Semua gred bahan api diesel	Stesen minyak	Mengisi tangki minyak asal kenderaan bagi maksud menjalankan fungsi kenderaan itu
3. Gula	Penjual borong	Sebagai ramuan bagi makanan dan minuman yang disediakan oleh pengusaha hotel bagi maksud penyajian di hotel itu
4. Tepung gandum	Penjual borong	Sebagai ramuan bagi makanan yang disediakan oleh pengusaha hotel bagi maksud penyajian di hotel itu”.

CONTROL OF SUPPLIES ACT 1961

CONTROL OF SUPPLIES (EXEMPTION) (AMENDMENT) ORDER 2021

IN exercise of the powers conferred by section 5A of the Control of Supplies Act 1961 [Act 122], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Control of Supplies (Exemption) (Amendment) Order 2021**.

(2) This Order comes into operation on 15 October 2021.

Amendment of paragraph 5

2. The Control of Supplies (Exemption) Order 1991 [*P.U. (A) 77/1991*], which is referred to as the “principal Order” in this Order, is amended by substituting for paragraph 5 the following paragraph:

“Exemption from 5. Any person who in the course of trade or business regulation 18 of the purchases any scheduled article specified in column (1) of the Control of Supplies Third Schedule from the seller or supplier specified in Regulations 1974. column (2) for the use specified in column (3) is exempted from the application of regulation 18 of the Control of Supplies Regulations 1974.”.

Substitution of Third Schedule

3. The principal Order is amended by substituting for the Third Schedule the following schedule:

"THIRD SCHEDULE

(Paragraph 5)

(1)	(2)	(3)
<i>Scheduled article</i>	<i>Seller/Supplier</i>	<i>Use</i>
1. All grades of petrol	Petrol station	Filling the vehicle's original fuel tank for the purpose of carrying out the function of the vehicle
2. All grades of diesel fuel	Petrol station	Filling the vehicle's original fuel tank for the purpose of carrying out the function of the vehicle
3. Sugar	Wholesaler	As ingredient for food and beverages prepared by the hotel operator for the purpose of serving at the hotel
4. Wheat flour	Wholesaler	As ingredient for food prepared by the hotel operator for the purpose of serving at the hotel".
