INTERNATIONAL TRADE IN ENDANGERED SPECIES
(AMENDMENT OF FIRST SCHEDULE) ORDER 2021

IN exercise of the powers conferred by subsections 6(2) and 6(3) of the International Trade in Endangered Species Act 2008 [*Act 686*], the Minister, with the consent of the State Authority of Sarawak, makes the following order:

Citation

1. This order may be cited as the **International Trade in Endangered Species (Amendment of First Schedule) Order 2021**.

Amendment of First Schedule

2. The International Trade in Endangered Species Act 2008 is amended in the First Schedule in column Management Authority in relation to item “Forests Department Sarawak and Sarawak Forestry Corporation” by deleting the words “Forests Department Sarawak and”.
