DEPOSIT OF LIBRARY MATERIAL
(AMENDMENT OF SCHEDULE 1) ORDER 2021

IN exercise of the powers conferred by paragraph 10(c) of the Deposit of Library Material Act 1986 [Act 331], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Deposit of Library Material (Amendment of Schedule 1) Order 2021**.

(2) This Order comes into operation on 8 October 2021.

Amendment of Schedule 1

2. The Deposit of Library Material Act 1986 is amended by substituting for Schedule 1 the following schedule:
