AKTA PERKHIDMATAN KEWANGAN 2013

PERINTAH PERKHIDMATAN KEWANGAN (PENGECUALIAN) (NO. 4) 2021

PADA menjalankan kuasa yang diberikan oleh seksyen 263 Akta Perkhidmatan Kewangan 2013 [*Akta 758*], Menteri, atas syor Bank, membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Perkhidmatan Kewangan (Pengecualian) (No. 4) 2021**.

(2) Perintah ini mula berkuat kuasa pada 1 Oktober 2021.

**Pengecualian daripada subseksyen 17(1) dan seksyen 18**

2. (1) Suatu pengendali sistem pembayaran yang menyediakan perkhidmatan pemeroleh saudagar dan bukan peserta langsung suatu rangkaian instrumen pembayaran dikecualikan daripada pemakaian subseksyen 17(1) dan seksyen 18 Akta.

(2) Dalam Perintah ini, “peserta langsung” ertinya anggota prinsipal suatu rangkaian instrumen pembayaran bagi maksud menyediakan perkhidmatan pemeroleh saudagar.

FINANCIAL SERVICES ACT 2013

FINANCIAL SERVICES (EXEMPTION) (NO. 4) ORDER 2021

IN exercise of the powers conferred by section 263 of the Financial Services Act 2013 [Act 758], the Minister, on the recommendation of the Bank, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Financial Services (Exemption) (No. 4) Order 2021**.

(2) This Order comes into operation on 1 October 2021.

**Exemption from subsection 17(1) and section 18**

2. (1) An operator of a payment system who provides merchant acquiring services and is not a direct participant of a payment instrument network is exempted from the application of subsection 17(1) and section 18 of the Act.

(2) In this Order, “direct participant” means a principal member of a payment instrument network for the purpose of providing merchant acquiring services.
