REGISTRATION OF PHARMACISTS (AMENDMENT OF FIRST SCHEDULE) ORDER 2021

IN exercise of the powers conferred by subsection 6(3) of the Registration of Pharmacists Act 1951 [*Act 371*], the Minister, after consulting the Board, makes the following order:

Citation

1. This order may be cited as the **Registration of Pharmacists (Amendment of First Schedule) Order 2021**.

Amendment of First Schedule

2. The First Schedule to the Registration of Pharmacists Act 1951 is amended in relation to the country of “Malaysia”, by substituting for the item “QUEST International University Perak (QIUP)” the item “Quest International University (QIU) (formerly known as QUEST International University Perak (QIUP))”.
